



- 5. **Additional Charges:** Applicant will be charged the actual cost for any Public Works Department staff services deemed necessary, along with a 20% administrative fee, for any time that Public Works spends as a direct result of the event, during or after the event; including any trash removal.
- 6. Applicant and their guests must comply with all rules and regulations, including the other Park Use Regulations in Ordinance No. 505 (attached), or a penalty may be imposed.

I hereby certify that, as the applicant and organizer of this event, I agree that event attendees and I will adhere to the rules and regulations of the City of Aumsville; that we understand that we use the park at our own risk; and hold the City of Aumsville harmless from any and all liability, claims, causes, actions, suits, loss, damage, or expense of any kind or description which may be claimed against or incurred by the agents or invitees and shall indemnify the City of Aumsville against and hold the City of Aumsville harmless from same, including attorney fees which may arise out of or be connected with or result from the use of city park facilities or equipment during the period of this permit. I have read, I understand, and agree to comply with Ordinance No. 505 set forth herein. I further pledge that I am of legal age and will be personally responsible for the care of the facility during its use. **Further, I will be responsible for the repair or damage to equipment, grounds, or the facility should any occur and for the replacement of any inventory or equipment lost or damaged during the use for which I have accepted responsibility for our organization/group/individual; to the satisfaction of the city.** I further understand that this permit is revocable at any time and that the permit is not transferable.

I also hereby **certify that we use the park at our own risk, and that I have homeowner's/renter's and/or business insurance coverage** and agree to reimburse and hold the City of Aumsville harmless from any and all liability, claims, causes, actions, suits, loss, damage, or expense of any kind or description which may be claimed against or incurred by the agents or invitees and shall indemnify the City of Aumsville against and hold the City of Aumsville harmless from same, including attorney fees which may arise out of or be connected with or result from the use of the park or equipment during the period of reservation.
