The certificate of an abstract or title company duly incorporated under the laws of Oregon shall be deemed a compliance with this provision.
- d. The certificate of the notary public or other official authorized to make acknowledgments, acknowledging property owners signature on this petition, or notarized affidavit, whichever is applicable.
