## **AUMSVILLE CITY COUNCIL Minutes – June 24, 2019**

Mayor Clevenger called the meeting to order at 7:00 PM in the Chester Bridges Memorial Community Center, 555 Main Street, Aumsville, Oregon. Council present was: Mayor Derek Clevenger and Councilors Nico Casarez, Jim Case, Angelica Ceja, Larry Purdy, and Della Seney. Council Gus Bedwell joined via cell phone at 7:03 PM. City Administrator Ron Harding (CA Harding), and City Clerk Colleen Rogers (CC Rogers) were also present.

Approval of Agenda: Mayor Clevenger asked for a motion to approve the agenda. Councilor Seney requested that we add June 14 to item 3A where the date was missing. Councilor Seney motioned to approve the agenda with the amended date. Councilor Casarez seconded. Motion APPROVED 6-0: (Yes: Clevenger, Casarez, Case, Ceja, Purdy, and Seney. No: None.)

**VISITORS:** There were twelve visitors in the audience and no one asked to speak during the public comment period.

**CONSENT AGENDA:** Council reviewed the June 7, 2019 through June 14, 2019 check registers and the April 22, 2019 Council meeting minutes. Councilor Casarez requested that, in the second paragraph of the minutes, the word 'out' be corrected to say 'our' instead. Councilor Seney requested that on page 3, paragraph 7, the last sentence to end after the word interchange. The last portion of the sentence was incorrect. Councilor Casarez moved to approve the consent agenda with changes as outlined. Councilor Ceja seconded. Motion APPROVED 7-0: (Yes: Clevenger, Bedwell, Casarez, Case, Ceja, Purdy, and Seney. No: None.)

**OLD BUSINESS: NONE** 

#### **NEW BUSINESS:**

CA Harding explained that the ordinance amendments of Ord. 405 and 505, to allow the terms of the Corn Festival Memorandum of Understanding (MOU), are based on the requests of Council at a previous meeting. He stated that the City Attorney reviewed the ordinance as well as the MOU and made changes that he felt were necessary, focusing mainly on indemnity. He pointed out that, in their packets, they also have a copy of the executed contract for the use of the property north of Porter-Boone Park.

Council discussed the MOU and made the following suggested edits:

- "The City" item #5; Change the wording from 'service dogs' to 'service animals."
- "The Corn Festival" item #8; the word 'train' should be 'trained.'
- Item #9 "Beer garden confinement" change the wording from 'one entry point to 'a single-entry and exit point.'
- Item #11 repetitive wording; delete the second \$2,000,000. Purdy asked for clarification of the insurance amount and it was discussed.
- Item #14 at the beginning of the sentence 'AFC' should be 'ACF.'
- Bottom of page 3 'order the closer' should be 'order the closure.'

Mayor Clevenger read by title only No. 668 AN ORDINANCE AMENDING THE SECTIONS OF ORDINANCES 405 AND 505 REGULATING THE CONSUMPTION OF ALCOHOLIC BEVERAGES IN CITY PARKS AND PUBLIC PLACES. Councilor Casarez moved to approve the first reading of Ordinance No. 668 as presented. Councilor Ceja seconded. Motion APPROVED 5-2: (Yes: Bedwell, Clevenger, Casarez, Case, and Ceja. No: Purdy and Seney).

CA Harding requested that Council move the second reading and adoption of the ordinance to the next meeting. He explained that, based on our City Charter, the next step is that when the vote is not unanimous it goes onto the next meeting agenda for the second reading and adoption. He added that because there are edits to the MOU it would be better to adopt the ordinance changes and the corrected MOU at the next meeting.

#### CITY ADMINISTRATOR'S REPORT:

CA Harding reported that Public Works staff have been busy with Main Street beautification. They have hung flower baskets and flags. They have also done some cleaning at the skate park for better visibility. He announced that the summer events have started. We kicked off the season with a Movie-in-the-Park on June 15<sup>th</sup>, followed by the first Friday Kid's on June 21<sup>st</sup>. We are gearing up for the Super Hero Carnival that is scheduled for June 29<sup>th</sup>. He stated that we have about 12 businesses and agencies participating this year. It should be a fun event for all.

CA Harding reported the Vision Committee has been meeting once a month. He stated that they will have a couple more meetings then he will compile the information they've gathered. He will take it back to the committee and, once they sign off on it, it will come to Council for review. We conduct some community-wide open houses to get the community involved in the process as well.

CA Harding announced that we have hired Ryanne Crowther to fill our Office Assistant position at City Hall.
