Minutes – February 24, 2020

Mayor Pro-tem Seney called the meeting to order at 7:00 PM in the Chester Bridges Memorial Community Center, 555 Main Street, Aumsville, Oregon. Council present was: Council President Della Seney and Councilors Gus Bedwell, Angelica Ceja, and Larry Purdy. Council absent was: Mayor Derek Clevenger, Nico Casarez and Jim Case. City Administrator Ron Harding (CA Harding), and City Clerk Colleen Rogers (CC Rogers) were also present.
