#### **STAFF REPORT**

**TO:** City of Aumsville City Council

**FROM:** Matthew Etzel, Aumsville Public Works

**SUBJECT:** Electrical Maude's Village

**Recommendation:** Award the contract between the City of Aumsville and Pacific Coast Electric in the amount of \$40,950.00 from the general fund 010-804. The city has funds in this account to support this proposal without a negative impact on the budget.

**Background:** Our Public Works crew has completed the building construction on Maude's Village. When we started this work we anticipated the need for electricity in the building. Unfortunately, our pre-planning has stalled our final approval of the building permit on the building. Marion County Building Department won't final the construction phase until the electrical is completed.

Public Works staff worked with a licensed electrical contractor to develop a scope of work that could be put out to bid to three electrical contractors. The scope is attached to the proposal submitted by Pacific Coast Electrical for you to view. We did this to ensure all permitting requirements would be met, and that the project would be bid the same based on the scope staff and the electrician developed before a mandatory bid meeting attended by all the bidders.

There will be some additional costs associated with this work beyond the approved proposal from Pacific Coast Electrical. Public Works staff will be doing all the trenching and installation of the electrical conduit. We will need to construct an electrical meter base support that will also serve as a reader board for the Saturday market and Maude's Village area of the park. The cost for the conduit is included in the Pacific Coast Electricals proposal but staff time, any equipment rentals, and the construction material to build the meter base and reader board will be separate from this contract. Staff doesn't anticipate those costs exceeding \$2,500.00.
