Aumsville Residents,

As you may or may not know, my staff and I work on hundreds of issues at a time. People are often focused on issues that affect them directly or personally, and I understand that, but sometimes its easy to forget we are working on every issue at the same time.

Our jobs should address each of these issues as it's the most important issue in front of us. However, what's important to one person isn't important to all, so often we will have lots of different demands.

It's also important to remember that we work to benefit over 4200 residents, property owners and businesses. What may be your priority isn't necessarily your neighbor's priority. Our role is to take in that information and work toward accomplishing as many things as possible.

What I think the community should know is we do our best based on what we have to work with, and I believe we are doing a lot of great things. However, if you have a concern, want to volunteer, want to report a problem or complaint about a neighbor, person, or something in the city, we have a process to document and follow up on any of those issues. The city website has a form we call a "Citizen Action Form". We created it specifically to allow residents a documented forum to address anything. The form can be found and filled out on the city website or at city hall in person. The form allows for anyone to make a comment, and then staff will direct those comments to the appropriate department but also provide an answer back to whoever fills out the form. I would hope people would also feel free to share compliments about service, parks, a friendly neighbor, business owner or anything else you would like to communicate.

The city website also has a way to contact me directly. On the top right of the city website there is a button that says email the city administrator. This will generate an email directly to me. Anyone can always call or walk into city hall and simply ask for me as well.

I think the city is on track to make some milestone accomplishments. At the same time, we have some

significant challenges, but by working together I am very positive that we will accomplish many of these projects to help improve our community.

The accomplishments of this community in recent years have been notable and I believe made possible by our elected mayors and council, who have provided good policies and consistent directions. Consistency is key. Even though we have had changes in our council, they have mostly been supportive to the future plans and directions, which in turn maximizes resources.

Based on our community interaction, surveys and contacts we feel overall that community satisfaction, communication, and engagement are at an all-time high. We have so much more to do as the community is ever-evolving, and the desires, needs, and improvements are forever changing.

The community worked for several years to develop a community wide vision. That process included hundreds of community members, business and elected officials. The vision plan is on the city website and was approved in 2020. Since then we have been working to implement elements consistent with that vision. New parks, improved amenities, cleaner for modern development, community art, and needed community facilities.

I am confident we will continue to work toward accomplishing good things in the years to come. The important thing for us to do is stay focused on the betterment of our community and communicate well about events and changes before us.

You may have seen the social media post related to the wastewater system requirements. Today in the news was a fine to the city of Silverton for \$42,000 for the same or similar wastewater violations we are hoping to avoid. Paying large fines like this is simply not sustainable and we do not want to put the city or residents in that position.

To Whom It May Concern,

In 2017, DEQ conducted an annual review of Aumsville's wastewater system and concluded that the city's system is unable to meet the EPA and DEQ standards for NPDES with effluent waste, particularly for TMDL and ammonia levels. DEQ took an immediate enforcement position with the city. If no changes were to be made, the city would face high fines by DEQ and EPA. In late 2017, the city signed a memorandum agreement order to install a mechanical processing system that would introduce the necessary treatment process to lower the ammonia levels in the output, and provide for overall cleaner water in the final stages of processing. The new process would result in beneficial environmental impacts to Beaver Creek and local groundwater.

With just 4,000 residents, the cost of constructing a new facility without outside assistance is cost-prohibitive and greatly decreases the affordability of living in Aumsville. The cost of operating the new sewer system alone would double the existing monthly sewer bill. If we include capital costs, our estimates would put the sewer portion of the utility bill between \$200-250 per month. After adding the water to this price, the utility bill would be over \$300 per month for the average water/sewer bill in the city. As a small, rural community just above the medium income threshold for HUD based on the most recent census, this heavily increased cost would leave many of the residents of Aumsville who are on fixed incomes struggling to cover utility costs at this level.

As a resident of Aumsville, I know families cannot afford such a drastic increase in utility costs. Please assist our community in leveraging state and federal grants to help fund this required project.

What can we NOT bring?

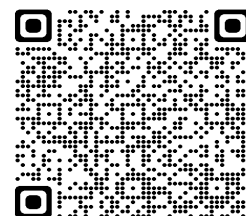

ON-LINE bids for the **Boone Well #3 and Mill Creek Well #1 Drilling Project** will be received on behalf of the **City of Aumsville** by Christopher J. Brugato, P.E., Project Manager, of Westech Engineering, until the bid closing time of **2:00 p.m. local time on April 20, 2023**. Paper bids will not be accepted for this project.

All bidders must register with and obtain bidding documents from the online plan distribution system (QuestCDN) which can be accessed at Westech Engineering’s website at <http://www.westech-eng.com> (under the currently bidding tab). Only firms that obtain bidding documents from this online plan distribution system will have access to the online bidding system, which can also be accessed at Westech Engineering’s website as noted above, or directly from QuestCDN at www.questcdn.com. All firms choosing to submit a bid must submit an on-line bid along with all required bidding documents, and pay a \$30.00 bidding fee through QuestCDN. Bids will be opened and evaluated shortly after the bid closing time, but written bid tabulations will not be finalized or released until after 4:00 p.m. (the *submittal deadline for the “First-Tier Subcontractor Disclosure Form”*).

By no later than 4:00 p.m. local time on **April 20, 2023** (i.e. 2 working hours after the bid closing), each bidder shall submit through the on-line bidding system noted above, the “First Tier Subcontractor Disclosure Form” contained in the bidding documents. This form shall be submitted regardless of the bid total. Bidders who fail to submit the required disclosure form will be considered non-responsive, and their bid will not be considered for award. The Project consists of the construction of drilling a minimum of one new municipal water supply well (Boone Well #3) with the potential additive alternate to drill a second water supply well (Mill Creek Well #1). Both wells are anticipated to yield approximately 150 gpm with completed well depths of approximately 190 feet.

Aumsville Historical Society met on Thursday, March 9th in the community center. AHS business was brought up to date. Aumsville Police Chief Damian Flowers was the guest speaker. He discussed his law enforcement history and gave updates pertaining to the operation of Aumsville's police department.

Oregon has a surprising number of ghost towns. Most originated as fast growing communities which accommodated mining,

lumbering or railroad construction. Two of these settlements in Marion County are very interesting and not too far from home. The Aurora Colony was founded as a religious commune. That group has gone. Aurora remains as a community of about 1300 residents. In many ways, it has a strong connection to its past.

Jawbone Flats at Opal Creek was developed in 1859 when gold was discovered there. Eventually, the mine failed and the people moved away. Some old structures remain. These suffered through heavy snow, strong winds and the 2020 Beachie Creek fire.

Other ghost towns are farther away. Kent, in Sherman County (84 east, 97 south beyond Grass Valley) is a rural relic. It had businesses, a grain elevator, was

on the railway and had a population of several hundred residents in the early 1900s. Like numerous other places of this kind, they are not near a population center, so there are very few services for travelers. Visitors should carry food, water, first aid supplies and have a full tank of fuel.

The museum will open its new season on April 1st. The open hours will be Saturdays 11 am to 2 pm, except when the Saturday is associated with a holiday weekend. The next AHS meeting will be held on Thursday, April 13th, snacks and chat at 6 pm followed by the meeting at 6:30. For additional information, please phone Ted Shepard at 503-749-2744.

Good Day, neighbor!

Budget time is here for the Fire District, as our Fiscal Year begins July 1. The District has tabled further action on replacing/remodeling the Administrative Office until the existing General Obligation Bond expires in 2025, which will reduce the tax obligation and allow the District to explore finance options at that time. Current cost estimates, along with an uncertain economic outlook make this a prudent course of action.

The District has applied for staffing grants from both State and Federal programs, due to increased

workload and lack of available volunteers in the community. These are highly competitive grants that are awarded based on need, risk, etc. Aumsville successfully received a seasonal grant last year that resulted in a great benefit to the District during our dry season.

The annual regional recruit academy began in January and the single volunteer we have enrolled is doing well. We look forward to having him as a part of our response force!

The Board of Directors is engaged in researching options to replace the Fire Chief as I am retiring in June. A survey was conducted among the existing staff and volunteers as well as neighboring Chief Officers and the Board is considering the results at this time.

The reserves worked a total of 45.5 hours during the month of February: 45.5 volunteer hours and 0 paid hours.

On February 9th, we had a booth at the Cascade High School Job Fair. Officer Wright brought out a set of Drunk Buster Goggles. They simulate what a person would see at a blood alcohol Content of .15% to .25%. The legal limit in Oregon is a blood alcohol level below a .08%. Officer Wright and Reserve Officer Hagen let some of the students try on the goggles and attempt one of the three standardized field sobriety tests that we use out in the field.

February 14th, the Chief accepted an invitation to attend a Formal Luncheon at the Aumsville Elementary School. He was able to interact with the kids and visit with the Principal, Zach Mintzer.

On February 17th, 2023, Officer Angela Robinson graduated the DPSST Academy (Department of Public Safety Standards Training). Be looking for her out on patrols and at city events.

We've received results from City/County Insurance regarding the "Best Practices" evaluation for the PD operations. We received a 97% rating. Although we have a few improvements to make, our department is being used as an example to other agencies.

Why We Ask You to Apply for a “Type A” Permit with the City

The Purpose of Building Permits :

No matter what kind of job you’re completing, it’s important that you have the right building permits to do it.

The city does not charge for a “Type A” permit, but if a permit involves electrical, mechanical, or structural work, a Marion County Building Permit may be required. The city helps facilitate this process.

Safety:

The main purpose of any building, structure or electrical permits is to ensure safety. By enforcing proper safety standards, you and other occupants of a space have a better chance to avoid any accidents or issues during the construction process.

Save You Money:

Many people are swayed away from proper residential building permits because of the lengthy process, but it could cost much more in the long run. We can process a “Type A Permit” usually in a day or two. Below are examples of what the city checks for:

- There may be a utility easement on your property you are not aware of.
- Setbacks from property lines.
- Size and height restrictions for accessory structures and fences.
- Number of structures allowed.
- Architectural requirements.

If you build a shed, add concrete, or add on to your house and it does not meet the city development code, you will have to move or remove the project.

Keeps Your Insurance Valid:

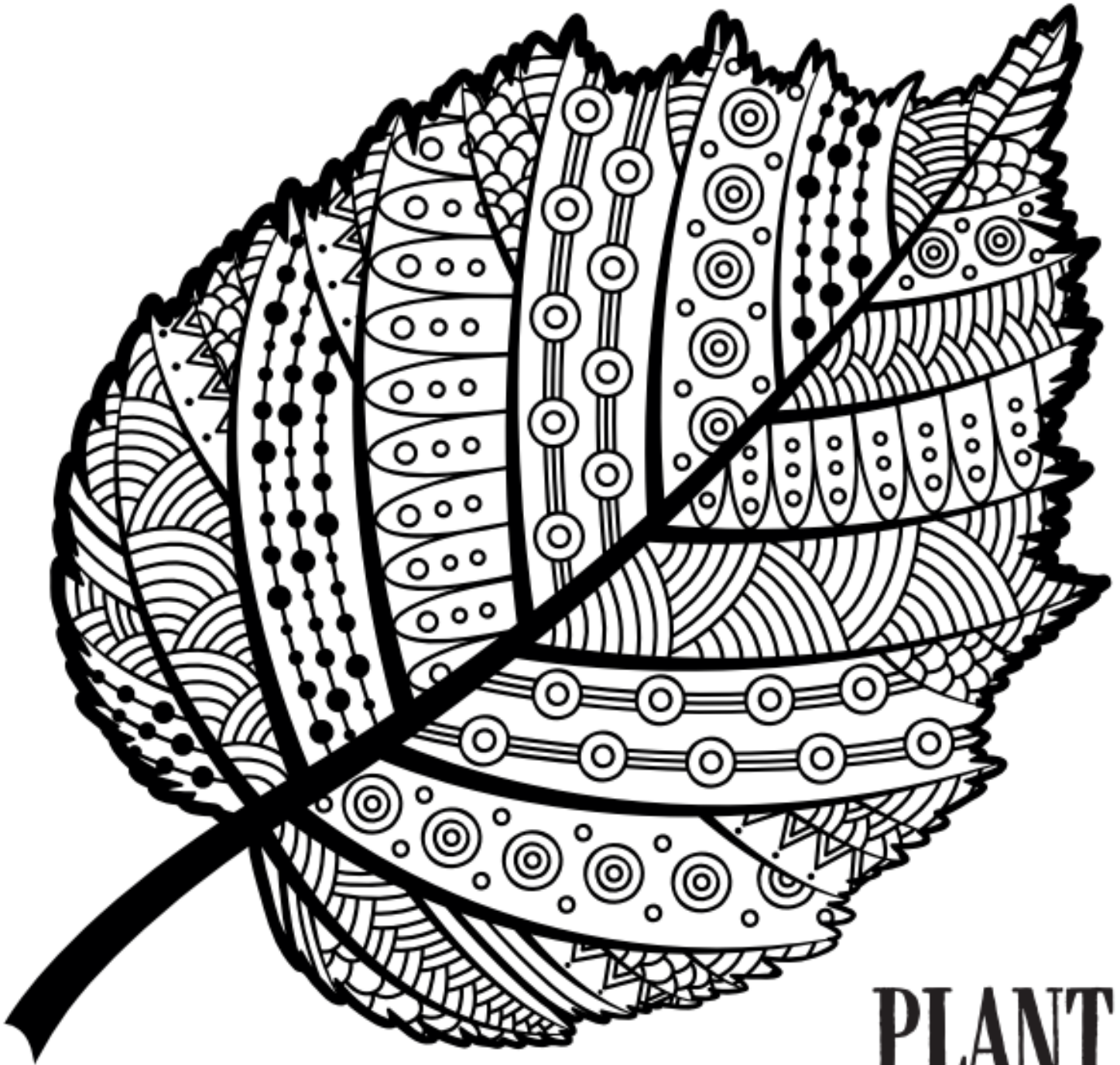
If you build something without a permit and make a mistake or sustain an injury, your insurance may not cover it. However, building with a permit verifies that you understand the risks involved and that you have received permission to move forward with your project.

Value When Selling Your Home :

If you perform renovations on your home without a permit, a potential buyer will find out. If you are selling your home, you should be able to provide legal proof that you performed all renovations with the proper permits. The county maintains a data base of prior building permits and the status of that permit.

February 27, 2023 Meeting Minutes

Mayor Angelica Ceja called the meeting to order at 7:02PM. Present in-person were Councilors Lee, Seney, Wallace and Wick. Council absent: Councilors Casarez and Cox. Staff present: City Administrator (CA) Ron Harding, Chief of Police Damian Flowers, and City Clerk Traci Nichols.

Council approved the minutes from the February 13, 2023 regular meeting as presented.

NEW BUSINESS: Signature Authorization Changes – Riverview Community Bank Accounts. Councilor Wallace volunteered as an authorized signer for the accounts, stating she had broad availability. Council voted to approve Councilor Wallace as an authorized signer on the City's two Riverview Community Bank accounts, replacing former Mayor

Derek Clevenger.

Preliminary Design Report Proposal – Westech Engineering. CA Harding shared with Council a proposal to enter into agreement with Westech to complete a Preliminary Design Report (roughly 20% of the full design) of a new wastewater treatment facility. The Design Report will allow DEQ to review the proposed improvements and suggest changes, if necessary, before the design is too far along to make adjustments. Council present unanimously approved **Resolution 1-23 – A Resolution Approving a Proposal From Westech Engineering for a 25-30 Percent Preliminary Design for the New Wastewater Treatment Facility With a Not to Exceed Amount of \$125,000.**

CITY ADMINISTRATOR REPORT: City Administrator Harding shared with Council the bidding process for the new Public

Works building project. He indicated that the numbers bid were higher than he would like, and hoped the numbers would trend down as the process progressed. Staff will review and score the bids. Once completed, the City may decide to reject the project. CA Harding discussed the water reservoir project and described the process thus far. More information would be coming before Council.

MAYOR/COUNCIL REPORTS AND INITIATIVES: Councilor Seney brought to Council attention the upcoming planning meeting and discussion on the new Eastside Park project.

Mayor Ceja adjourned the meeting without prejudice at 7:30PM.

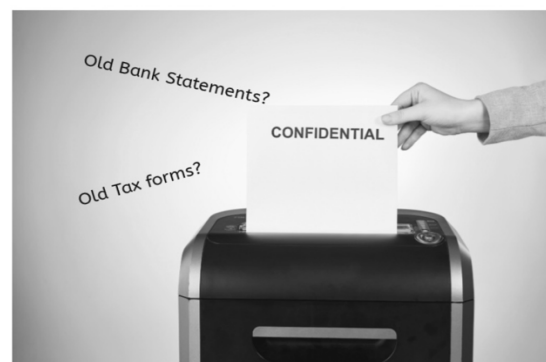

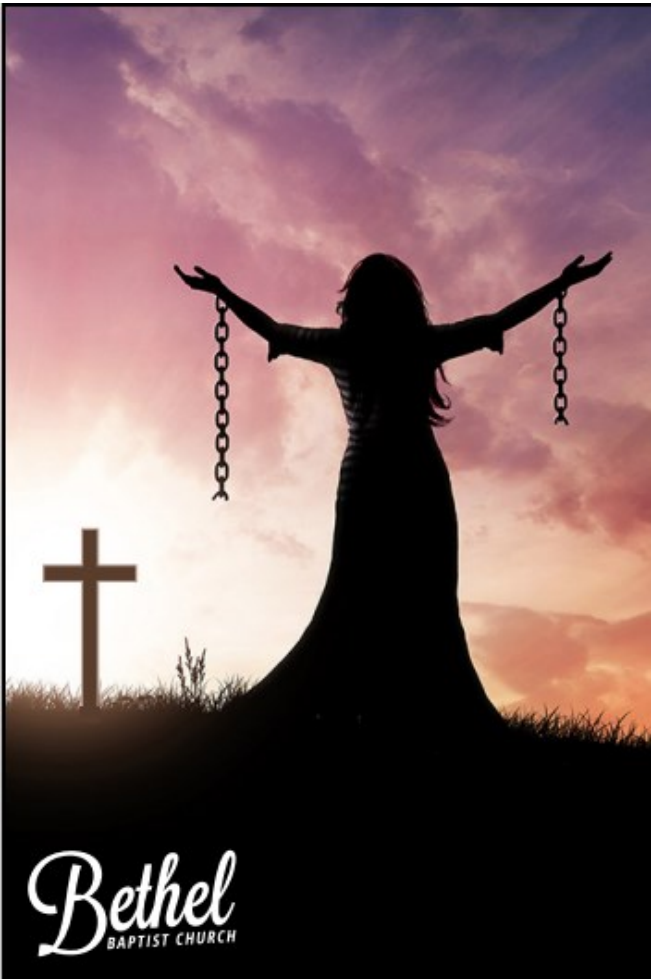

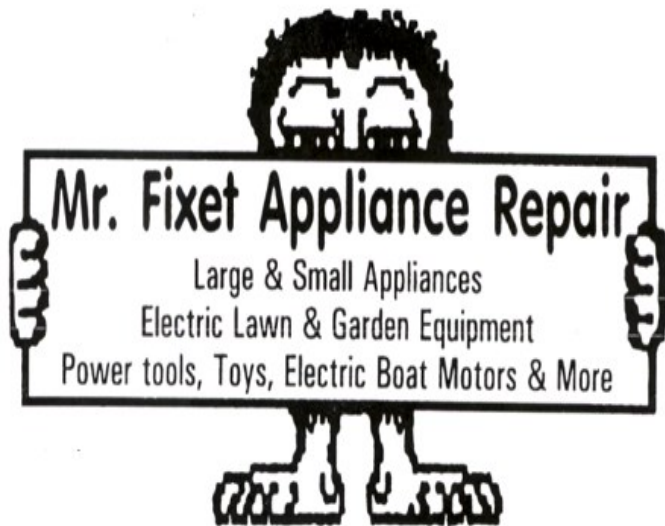
