#### CORN HUSK DOLL

Want an easy corn(y) craft to try with your kids? Dry your husks from your free corn and then make Corn Husk Dolls. You can enter your dolls into the Great Corn Challenge! See page 3 for more details.

- 1. Soak dried husks in water for 10 minutes and then blot dry.
- 2. Lay 4 or 6 (always even number) husks in a stack.
- 3. Tie the husks together about 1 inch from top.
- 4. Separate the husks into even portions, half on either side, fold over to cover the tied twine portion.



5. Tie husks about an inch down to create the head.

6. Take a separate husk (not in your bundle) and roll it, tie at both ends to make arms.

7. Position arm below the head with half of the husks on either side.

8. Tie a waist just below the arms.

9. Leave the husks below for a skirt or for pants, separate them equally and tie at ankles and knees.

10. Decorate with yarn for hair or fabric for clothes.

#### **REPRESENTATIVE'S MESSAGE**

#### Hello ~

Last week I was asked by the Governor to serve on the Healthy Schools Reopening Council. As a mother and a grandmother education is an issue I care deeply about. I am grateful to have the opportunity to work with parents, educators, and health ex-

perts from around the state along with some of my colleagues on the Governor's plan for schools to be able to safely reopen this fall.

The council had its first meeting on Tuesday, July 7<sup>th</sup> and met again July 15<sup>th</sup>. We will meet several more times in the coming months and will advise Governor Brown on reopening the schools this fall. I have heard from my community how important this issue is for the health and welfare of our students. As with all issues affecting the constituents of HD19 I welcome your comments and hope to hear from you on this critically important item. Our children are counting on us.

There is also a survey that ODE has had open since this spring, and you may still participate. To date over 12,000 responses have been received. <u>https://</u> <u>www.surveymonkey.com/r/readyschools</u>.

It is anticipated that we will be called back into a 2nd special session in the middle of August. Currently the scope of this potential session is being discussed. It is long past due to look at Oregon's financial situation and the effects COVID-19 has had on our economy. We must begin to chart a path forward for our children, our businesses, and our essential services.

Summer is here and the weather is beautiful I am happy to be out in the district and joining Senator Denyc Boles at Wildwood Park, located on Fifth Street, Aumsville August 17<sup>th</sup> from 5:30pm-6:30pm. We will also be in Turner on August 19<sup>th</sup> from 5:30pm-6:30pm at Turner Lake Park 5203 Holly St. Bring your chair or blanket and mask and stop by if you have time to chat.

Governor Brown announced on July 13th new requirements for face covering and limits on social gatherings in response to the dramatic rise in COVID-19 case counts across the state over the last several weeks. Effective Wednesday, July 15, Oregon's face covering requirement will be expanded to apply to outdoor public spaces when six feet of distance cannot be maintained. In addition, indoor social get-togethers of more than ten people will be prohibited. The gathering limit applies only to indoor social get-togethers. This new rule does not currently change the operation of businesses or churches. Governor Brown emphasized that failure to comply with the new requirements would lead to more outbreaks of COVID-19 and more restrictive closures that will significantly impact Oregon's communities. DMV is continuing to expand services currently available. They have announced that Real ID is now available. Real ID-compliant licenses and ID cards to Oregonians who meet the federal requirements and bring the required documentation to their DMV appointment only. In the interim if we can be of help to you as you navigate your state government please call or email. My door is always open and my staff, Pam McClain, Lena Prine, and I welcome your participation. As your state representative, I am here to listen, respond, and lead.

According to the timeline, these are to be completed by August 14<sup>th</sup>. Every community needs an appropriate place to bury those who have passed away. The Porter family history says that the first person buried in Aumsville's cemetery was Sarah Coffey Porter, the first wife of



William Porter. The Porter and Coffey families came over the Oregon Trail in 1848. Several weeks after their arrival, Sarah passed away. She was actually buried on Butler land, which is several miles north of the places where the Coffeys and Porters settled. There was no Aumsville at that time.


In 1873 Thomas and Matilda Butler conveyed to Aumsville Cemetery Association representatives Henry Smith, J.W. Shaff and William Porter, two acres to be used for burials. The price was \$25. In 1942 Tony and Lena Steinkamp sold the association about half an acre for ten dollars. In 1956 Philip and Regina Albus conveyed land amounting to about 16 feet on the north, south and east sides of the cemetery.

WINTER HOURS – OPEN BY APPOINTMENT www.ausmvillehs.com The Porters are buried near the center of the cemetery. To the east the mountains can be seen in the distance. After William Porter's death, a stone was erected in memory of William, Sarah and William's second wife

Martha, who was Sarah's sister. The cemetery is east of Aumsville. To reach it, go east on Main, which becomes Mill Creek Road. Take Leverman to Albus, which goes over Route 22. At Steinkamp Road, go left. Westbound drivers on 22 can take the Golf Club Road exit. Go right onto Golf Club, left on Steinkamp. Pass Albus and continue to the cemetery. This secluded spot represents a great deal of history and continues to provide a final resting place for residents.

#### AUMSVILLE CITY COUNCIL

Minutes – June 22, 2020

Mayor Pro-tem Della Seney called the meeting to order at 7:07 PM via Zoom Conferencing. Council present was: Councilors Bedwell, Casarez, Ceja, Purdy, and Seney. Council absent was: Mayor Clevenger. City Administrator Ron Harding (CA Harding) and City Clerk Colleen Rogers (CC Rogers) were present via Zoom. The meeting was video recorded to be released later.

**<u>VISITORS</u>**: There were 5 online attendees. Log in information was provided for members of the community to listen to the discussion.

PUBLIC COMMENT: There were no public comments.

Council reviewed and unanimously approved the June 8, 2020 Council meeting minutes.

#### NEW BUSINESS:

Resolution No. 13-20 A RESOLUTION REPLACING RESOLUTION NO. 16-16, TO BE MARKED AS EXHIBIT "A" OF ORDINANCE NO. 308; SETTING COLLECTION FEES FOR SANTIAM SANITARY, DBA REPUBLIC SERVICES OF MARION COUNTY, IN CONNECTION WITH THE EXCLUSIVE FRANCHISE AGREEMENT BETWEEN THE CITY OF AUMSVILLE AND SANTIAM SANITARY SERVICE. <u>Councilor Bedwell moved to approve Resolution No. 13-20 as presented. Councilor</u> <u>Purdy seconded. Motion APPROVED 4-1: (Yes: Bedwell, Ceja, Purdy, and Seney. No: Casarez.)</u>

Council reviewed and unanimously authorized CA Harding to enter into the Mid-Valley Council of Governments (MVCOG) Planning Services Contract.

#### CITY ADMINISTRATOR'S REPORT:

CA Harding gave an update on COVID-19. He talked about the uptick in positive cases in Marion County. The city was awarded a reimbursement COVID relief fund of up to \$15,000 for expenses that we have incurred due to the pandemic. Things like portable hand washing stations, hand sanitizer, PPE, and the new glass partition in the lobby of city hall. It can't be used for waived utility late fees, disconnection fees, and things of that nature. The state is working on an economic development grant to distribute out to cities to help with local economy. Other than the lobby being closed, we've adjusted our processes and have been able to continue serving our citizen's needs.

CA Harding opened a discussion regarding the reopening of city parks. He explained the Phase 2 requirements for opening the parks and some of the difficulties for staff to meet the guidelines. One alternative that the Governor gives if you don't have the resources is the placement of signs stating that people can use the facilities at their own risk, and practice COVID-19 safety guidelines. He told Council that the restrooms will continue to be cleaned daily. CA Harding asked if we should open Wildwood park. Several councilmembers expressed concern because the size of the park and difficulty to maintain social distancing. CA Harding also said he was receiving inquiries from community members about the park.

CA Harding asked Council for feedback. Councilor Bedwell suggested that we leave the restrooms closed in all parks and it was discussed. Consensus of Council was to move forward with posting signage, leave restrooms open, and open all parks; except for Wildwood Park. It will remain closed and Council will revisit it at a future meeting. CA Harding agreed to check with other spray parks to see how they are approaching this issue and report back to council.

CA Harding recommended that Council continue with Zoom for the next meeting and Council concurred.

#### MAYOR/COUNCIL REPORTS AND INITIATIVES:

Councilor Purdy stated that he appreciates our Police Department and read a sample 'resolution of support'. He wants to recognize the dedication to our community evidenced by our police force. He asked for input from other councilors. Council members all agreed that they are supportive of our local law enforcement officers. The discussion was around current national events and whether this would be the right time. Council discussed alternative ways to show appreciation to the department. CA Harding suggested, rather than a resolution, add the statement to our website and it was discussed. Consensus of Council was for CA Harding and Chief Schmitz to meet and put something together that would be from Council to the officers. We will vet it through Councilor Purdy, then bring to the next Council meeting.

CA Harding stated the he wants Council to know that he is very proud of all city staff. They are working hard to make sure that our services continue through this pandemic. Our city police force focus on providing service to our community, their dedication to the job and residents is regardless of anything going on outside of the community. All agreed with CA Harding's statement.

Rachel Salsedo posted in the meeting chat a suggestion to create an appreciation banner that the community

could sign. CA Harding asked her to send him an email with her idea and she posted that she would.

**GOOD OF THE ORDER:** Councilor Seney stated that she will be sending out the City Administrator evaluation for his review. She asked that Council return them to her by July 8<sup>th</sup> so that she can have it ready for the next meeting.

The meeting adjourned at 8:39 PM without prejudice.

#### GRASS AND WEEDS PUBLIC NOTICE

No owner or person in charge of property shall allow noxious vegetation to be on the property, or in the rightof-way of a public thoroughfare abutting the property.

An owner or person in charge of property shall cut down or destroy grass, shrubbery, brush, weeds or other noxious vegetation as often as needed to prevent them from becoming unsightly, from becoming a fire hazard, or in the case of weeds or other noxious vegetation, from maturing or going to seed. Noxious vegetation is a nuisance in our community.
