DISASTER PREPAREDNESS TIPS

Prior to a Disaster:

- Learn how to shut off your gas, water, and electricity in case lines are damaged.
- Choose an out-of-state friend or relative that separated family members can call to report their whereabouts and conditions.
- Compile an inventory of home contents. Take pictures and/or video. Store in a safe place.
- Make sure your insurance coverage is up-to-date and reflects present property values.
- Conduct drills so your family knows the safe locations for each type of emergency. Decide how and where your family will reunite if separated.
- Prepare a kit that will allow you to be self-sufficient for at least three days.
- Learn first aid and CPR. The Fire District occasionally holds classes on this.
- Make arrangements for pets and livestock.



If you are evacuated:

- Follow the directions of local officials.
- Carry your kit with you.
- Unplug appliances: turn off gas and main water valve if possible.
- Tell someone outside of the area where you are going.
- Check on neighbors, especially elderly or disabled.
- Lock your home and leave.

After the disaster:

- Turn on portable radio or television for reports. Fully cooperate with public safety officials and instructions.
- Use a flashlight to check for gas and water leaks, broken wiring or sewage lines. If there is damage call the utility.
 - Keep streets clear for emergency vehicles.
 - Take pictures of the damage for insurance claims.
 - Do not attempt to re-light the gas pilot. Call the utility company.

distributed to many locations. Most communities had a local business. The ice man delivered to customers, who had kitchen ice boxes to keep their food cool. Anyone could purchase ice for special occasions, such as making ice cream. These days ice cream can be bought everywhere. Some people still like to make their own and there

cream ingredients were poured into a metal can, which was set in the center of a bucket-like container. A gear apparatus was placed onto the top of the can and secured to the rim of the bucket. The bucket was filled with chipped ice and rock salt. The salt decreased the temperature of the ice. The handle on the apparatus was turned. This rotated paddles inside the can. When turning became are various appliances, which can do that. very difficult, the ice cream was ready to eat.

Getting ice for making ice cream was another matter. During the winter, ice was cut from lakes and stored for later use. There were ice merchants, who harvested ice from northern glaciers and transported it to the south. Sometimes they arrived at their destination and found that the cargo had melted.

The issue of reopening the state continues to be an urgent issue. I am fully supportive of opening our schools, gyms and other facilities as soon as safely possible and will also be focusing on finding ways to support small business owners and other working families through these times.

This last week, I had the opportunity to visit the CTEC program in Salem, and also the Willamette Technical Center, which will be open to high school students in Aumsville starting in the fall of 2021 with its first three career education programs. I also visited with nearly 75 teachers who are anxious to get back into the classroom safely and soon.

CASCADE SCHOOL DISTRICT UPDATES

The most exciting update for the Cascade School District is the return to in-person learning. Beginning Feb. 17, we will implement a hybrid model across our district. Students will either attend school in person on Mondays and Wednesdays or Tuesdays and Thursdays. On the days they are not in school, students will work on independent assignments as well as have teacher check-ins.

"We are excited to have students in our buildings on a more regular basis," said Cascade Superintendent, Darin Drill. "We've had one of the area's more robust limited inperson instruction programs going on since Oct. I know things will get even better as we offer more students more time in our buildings to access our tremendous staff members and socialize with their peers."

Cascade will implement some rigorous safety guidelines to help ensure the health and safety of students and staff. Cascade will also have a full online program for families who choose not to send their students for in-person learning.



On Jan. 21, Oregon released its high school graduation rates for the 2019-2020 school year. Cascade High School had a 93% graduation rate this past year. These are students that are tracked from their freshman year to graduation. That 93% mark is in the top 25 in the state. It's also above the state average of 82.6%.

"That [graduation rate] is a testament to the hard work of all our staff," said Drill. "From kindergarten up, we are preparing students for success after high school and I am proud to once again have one of the top graduation rates in the state."

HOUSING REHABILITATION LOANS AVAILABLE

Low-interest, deferred payment loans are available through Valley Development Initiatives. Here is how the Housing Rehabilitation Loan Program works:

You may qualify for a loan of up to \$25,000 to make repairs on your home. Eligible repairs include:

- Health and safety issues
- Electrical and plumbing upgrades
- Structural repairs
- Heating systems
- Roofing
- Siding
- Weatherization
- Accessibility

Four-percent (4%) APR simple interest rate accrues for the first five (5) years only. Zero interest accrues thereafter.

There are **no monthly payments**. The loan does not need to be repaid until sale or transfer of home. Then the loan is repaid from the proceeds of the sale.

To qualify for the loan you must:

- Own the home and the home is your primary residence.
- The combined income of all members of the household over 18 is under 80% of the median income for Marion County.
- Have equity in your property based upon 85% of the County's assessor's real market value or recent appraisal.

STATE REPRESENTATIVE'S REPORT



Hello -

Last month I was sworn in as State Representative for South Salem, Turner and Aumsville. It is an honor to serve. I am thankful for the overwhelming support I continue to receive from the people of House Dis-

trict 19.

This 2021 long-session will be unprecedented. The first two months of the 81st Legislative Assembly will take place virtually. The Capitol building, unfortunately, will remain closed to the public, while the legislature meets remotely and then in person from time to time to debate legislation. My goal is to keep all avenues of communication open and easily accessible. Our office will work diligently under these unusual circumstances to set meeting times in an efficient manner. My committee assignments will demand a sufficient amount of time, and I ask you to please entrust your meeting time to my extremely capable staff if I am unavailable.

My committee assignments for the upcoming session are as follows: Vice-Chair on the House Behavioral Health Committee and a member of the House Health Care, Energy and Environment Committees, COVID-19, and Conduct. It is an honor to have been assigned to these committees by House leadership and for entrusting a vice-chair position to me for the 2021 legislative session. There are a number of critical issues we must address for Oregonians and I look

forward to the work ahead to ensure the constituents of House District 19 are being served well and fully represented in the legislature. In addition I will continue to serve on Governor Brown's Healthy Schools Reopening Council, and her Education Recovery Committee.

Many people have already begun to share their support, opposition, and or concern for legislation that has been introduced in both the House and the Senate. Over 3,000 bills have been dropped (submitted) for consideration this session in the House alone. Many of the bills won't ever be assigned for a hearing, and it may take months before a bill is heard. Prioritizing the legislation that is currently being considered will be first and foremost for my focus. However it is important that you communicate your thoughts regardless of the status of the bill, our office tracks all comments and if and when a bill moves up in priority we will have a record of thoughts and / or opinions pertaining to it.

AUMSVILLE CITY COUNCIL MINUTES

AUMSVILLE CITY COUNCIL

Minutes – December 14, 2020

The meeting was called to order at 7:02 PM via Zoom Conferencing. Council present was: Mayor Clevenger, Casarez, Ceja, Ecclestone, Purdy, and Seney. Council absent: None. City Administrator Ron Harding (CA Harding), City Clerk Colleen Rogers were also present via Zoom. The meeting was video recorded to be released later.

VISITORS: There were eight online attendees. Login information was provided for members of the community to listen to the discussion.

PUBLIC COMMENT:

Dayadevi Heart asked when the code changes will go into Ordinance No. 685 AN ORDINANCE REPEALING OReffect. CA Harding explained that Ordinances go into effect 30 days after they are adopted. The ordinances that were approved and adopted at the November 9th meeting went into effect on December 9th and those approved at this meeting will be in effect on January 13th.

Kenneth Oakes, local business owner, asked about a letter he sent to the city administrator to pass on to Council. CA Harding pointed out that the subject matter of the Ordinance No. 687 AN ORDINANCE LIMITING THE letter constitutes a possible ex-parte conversation having to do with Oregon Land Use Law. The letter is in legal review with the city attorney to determine if it does constitute an ex-parte conversation, which will decide whether it will come before Council or not. Mr. Oakes stated that his request is to change a zoning and the transportation system plan and asked how he can get the process started. Mayor Clevenger explained that first we need to get the legal review back from the attorney, then the next step is for Mr. Oakes to talk to CA Harding about the zone and transportation plan changes to discuss the proper process.

OLD BUSINESS: CA Harding summarized the staff report for the code updates. He explained that any of the proposed ordinances that had a fine associated with it, was modified to say "not to exceed" the fine amount. This allows the judge room for adjustments to the fines in minor cases. Cathy Ames asked if the nuisance ordinance would apply to Mobile Home parks. CA Harding stated that parts of the ordinance does apply. What it doesn't apply to are streets and parking issues. The best practice in a case of nuisance would be to fill out a Citizen Action Form with the city, unless it is an emergency, then dial 911. There were no further questions from the public or Council.

NEW BUSINESS:

Business Oregon notified us that the state was seeking to refinance outstanding bonds that would result is a net savings to cities that participated. The city has less than \$1,500,000 in outstanding bond debt. The savings over the life of the loan will be around \$200,000 in interest. CA Harding stated that he has responded as directed and the next step is to approve a resolution to memorialize our participation in refinancing the bonds.

Council unanimously approved Resolution No. 17-20 A RESOLUTION OF THE CITY OF AUMSVILLE AUTHORIZING REFUNDING OF A LOAN FROM THE WATER AND WASTEWATER FUND WITH THE OREGON INFRASTRUCTURE FINANCE AUTHORITY.

CITY ADMINISTRATOR'S REPORT:

CA Harding updated Council on the COVID-19 epidemic. The Aumsville zip code area had a rise and we are now at 131 positive cases since the beginning of the outbreak. Staff continues to maintain our current COVID-19 protocols.

CA Harding reported that the city received good feedback for our Holiday Event activities. He is very proud of staff for all the hard work that went into making these COVID friendly event successful.

Aumsville Youth Council (AYC) Update: Council received the proposed outline for the AYC that was presented to Cascade School District. CA Harding explained that the goal of the program is to cultivate a relationship between students and city government; also getting kids more involved in city activities.

MAYOR/COUNCIL REPORTS AND INITIATIVES:

Councilor Ecclestone reported that the Canyon Wildfire fundraising event was a success and they presented \$6000 to the Santiam Canyon Wildfire Fund.

GOOD OF THE ORDER: Councilor Purdy expressed his gratitude to the community for allowing him to serve on City Council for the past two years. It has been a great learning experience. He encouraged community members to get involved and let current Council members know how you feel about issues that are occurring in your city and stay active. He plans to continue to pray for every member of the community and Council.
