Aumsville Historical Society



Society's Aumsville Historical Museum has received a small book entitled FORT KLAMATH, FRONTIER POST IN OREGON, written by Buena Cobb Stone. It was published in 1964. Fort Klamath was an isolated US Army outpost at the end of the southern route of the Oregon Trail. It consisted of 1,000 acres, plus 3,000 acres of grassland to supply hay and grain for the horses. The modern-day location is south of Crater Lake on Highway 62. Basic structures had been built by the


soldiers. When the Civil War began, the soldiers were reassigned to battle zones. Civilian volunteers manned Fort Klamath for the duration of the war. The work was very strenuous. The construction continued. The volunteers responded to conflicts with the native tribes. Obtaining necessary supplies was an ongoing problem.

Regular army infantry and cavalry men returned in July 1867 and the volunteers went home. The fort underwent expansion: new barracks, hospital, stables, hay and grain storage barns and so on. By 1880 the conflicts with the tribes had subsided. In 1886 President Cleveland Grover ordered the elimination of many frontier forts. In 1889, Fort Klamath was the last Oregon fort to close. It consisted of 39 buildings and had a 125-foot flagpole. The area is very scenic and now has nearby tourist facilities.

On Saturday, February 10th AHS will have a potluck in Aumsville Community Center. Setup at 12:30 pm; food service at 1 pm. After lunch there will be announcements and a presentation.

While the museum has been closed for the winter, work has been taking place. Indexing has been updated to include all 2023 entries. Some damaged file folders have been replaced. Saturday openings of the museum will resume in April. Until then, visitors are welcome by appointment. Please contact Ted Shepard at 503-749-2744.

Aumsville City Council Minutes 1-8-24

Mayor Angelica Ceja called the meeting to order at 7:02 PM. Present were Mayor Angelica Ceja, Councilors Nico Casarez, Della Seney, Scott Lee, Doug Cox, Katie Wallace, and Walter Wick. absent: None. Staff Council present: City Administrator (CA) Ron Harding, Assistant Administrator Kirsti (ACA) Administrative Pizzuto and Assistant Celia Lemhouse. The meeting was video recorded to be released later.

AGENDA APPROVAL: Councilor Seney moved to approve the agenda as presented. Councilor Wick seconded. Council present voted unanimously to approve the agenda. Agenda approved. PRESENTATIONS: None.

VISITORS: None.

PUBLIC COMMENT: None.

CONSENT AGENDA Councilor Seney moved to approve the consent agenda as presented. Councilor Lee seconded the motion. Council present voted unanimously to approve the consent agenda. Motion passed.

OLD BUSINESS: None.

NEW BUSINESS: a) Westech Engineering-Wastewater Treatment Plant 100% Design Proposal ACA Pizzuto presented the design proposal for the Wastewater Treatment Plant. ACA Pizzuto explained there are new requirements from BABA (Build America, Buy America), which are new in the last couple of years. ACA Pizzuto stated that the proposal includes bid documents remove the to biosolids that have never been removed in their lifetime.

Councilor Cox asked if this was the final design. ACA Pizzuto explained this is the proposal to complete the 100% design since DEQ approved the completed 20% design previously. Councilor Seney moved to Approve the Westech Wastewater Treatment Plant Final Design and Engineering Services Proposal with a not-to-exceed amount of \$980,000 as presented by staff. Councilor Lee seconded. Council present voted unanimously to approve the motion. Motion passed.

2 b) FCS- Wastewater Financial Plan and Rate Forecast Contract Agreements ACA Pizzuto made herself available for questions regarding the staff reports. ACA stated that rate increases are inevitable with the increasing debt the city is accruing for the Wastewater Project, and that FCS Group was selected to complete a rate study in the previous Council meeting. ACA Pizzuto noted that there are add-ons to the presented proposal which the city could choose to include in a revised contract in the future. Councilor Senev moved to approve the FCS Group Agreement for the Wastewater Financial Plan and Rate Forecast with a not-to-exceed amount of \$23,080 as presented by staff. Councilor Lee seconded. Council present voted unanimously to approve the motion. Motion passed.

CITY ADMINISTRATOR REPORT: CA Harding stated that the two contracts that were presented during the meeting are very important contracts for the city. CA Harding stated most of the Westech contract will be funded through an ARPA grant the city received through Marion County, and the rest will come out of the direct ARPA award from the government. CA Harding stated we are on a roughly 2-year period of being into the construction of the Treatment Plant, which will require permanent and construction funding. CA Harding stated that the council will be having a strategy work session for event planning in the coming month, as well as the State of the City presentation on January 22nd of this year. CA Harding requested vacation time in February, and stated that the February 26th meeting may be canceled should no projects arise.

MAYOR/COUNCIL REPORTS AND INITIATIVES: Councilor Seney gave an update that the SKATS discuss meeting to Aumsville's status has been moved to February. Councilor Cox stated the Public Safety Council Meeting was January 9th, 2024. Council recommended they have name tags for when they go to meetings. Mayor Ceja gave a reminder for the ribbon cutting event at the Aumsville Community Food Pantry happening January 9th, 2024.

GOOD OF THE ORDER: None.

CORRESPONDENCE: None.

Mayor Ceja adjourned the meeting without prejudice at 7:28 PM.
