

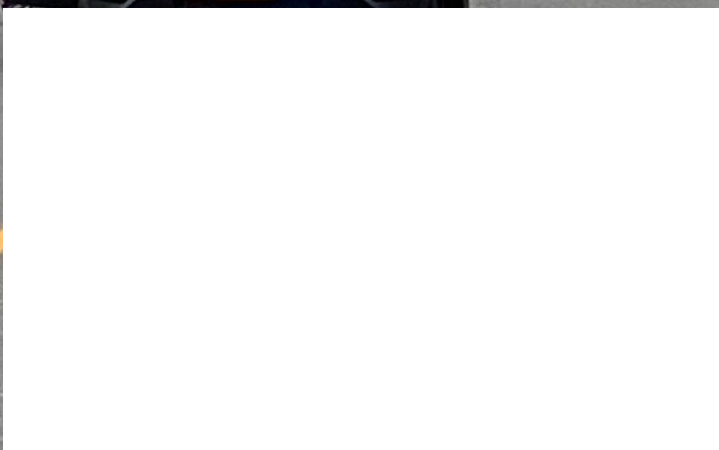

CASCADE SCHOOL DISTRICT

The Cascade School District wrapped up the school year on June 22.

“It’s been an unprecedented school year,” said Superintendent Darin Drill. “From wildfires to ice storms, not to mention the pandemic, everyone deserves a break. I hope staff and families have a relaxing summer.”

The district celebrated the Class of 2021 with three graduation ceremonies on June 9. In this graduating class, 172 students received diplomas, and 16 students graduated with honors diplomas.

“The class of 2021 has endured a lot,” added Drill. “But they are a resilient group of students, and I know they will go into the world and represent Cascade. I am glad we could celebrate them with an in-person graduation.”

The district also had promotions for fifth-grade students moving to junior high and eighth-graders moving up to high school.

As things transition into summer, the Cascade School District is planning summer programming for students in August. The district received \$900,000 in federal funding from the federal government’s American Rescue Plan Elementary and Secondary School Emergency Relief (ARP ESSER). This money must be used for credit recovery and enriching summer activities. The funds also have to be used by Sept. 30, 2021.

Each school in the district has planned its own summer programming. There are opportunities and activities for students from kindergarten through 12th grade.

“We are excited to be able to offer this engaging summer enrichment to our students,” Drill explained. “We know students missed out on a lot of activities this school year. The summer programming will create learning opportunities, but also hands-on fun for kids of all ages.”

STATE REPRESENTATIVE’S REPORT



Friends – In mid-April legislators were informed that we would have the ability to direct ARPA money to our house or senate districts. They were deemed “Local Community Investments.” Representatives received \$2 M and Senators \$4 M.

For HD 19 investments were directed to the City of Aumsville in the amount of \$300,000 for a tower well project within in their master park plan. It will help fund the overall \$2.5 M project. The City of Turner investment is also at \$300,000 and is earmarked for a complete renovation and code compliance of the Burkland Pool bathhouse. A full listing of Local Community Investments for HD 19 can be found on my legislative website at: <https://www.oregonlegislature.gov/moore-green>, under News and Information. By and large, funding was directed towards capital projects, grant programs, support services and technical assistance.

The 2021 session came to an end in June. We navigated a unique situation and the true intent of citizen involvement as it relates to the development of public policy was curtailed with the closure of the Capitol. The People were truly missed. A couple of important highlights include important wildfire relief and COVID recovery legislation. We were unsuccessful in fully funding k-12 education, it was a true disappointment as the state is awash in resources. Strides were made in expansion of access to health care as well as behavioral and mental health supports. For further information please visit my legislative website and look at the “End of Session” recap.

Oregon business owners are facing a shortage of employees as businesses begin to reopen. Currently the Oregon Department of Employment is in the process of reinstating unemployment Insurance benefit requirements. The requirements were suspended in 2020 in response to the pandemic. More information regarding the reinstatement of requirements may be found on the Oregon Employment department “Return to work “ at www.unemployment.oregon.gov/returntowork

As you read this letter, I hope that our state is fully opened for business, education, and recreation opportunities that we have all desperately missed. I look forward to connecting with you in-person via townhalls this summer and into the fall.

In the interim if we can be of help to you as you navigate your state government please call or email. My door is always open and my staff, Pam McClain, Lena Prine, and I welcome your participation. **As your state representative, I am here to listen, respond, and lead.**

STATE SENATOR’S MESSAGE



Dear Neighbors,

As the legislative session starts to wrap up, the Senate is finalizing key policy bills as well as passing department budgets to make sure our State stays up and running. In the last week, we passed several important bills including HB 2474 which expands family leave to help workers and families, HB 2261 which prevents online vape sales to protect youth from accessing nicotine products and HB 5514 which was Oregon’s K-12 Education Budget.

The \$9.3 billion allocation is the largest investment the Oregon Legislature has ever made to the State School Fund and is approximately 3% above the current service level. This has been a year of real hardship for many families. Most students learn best through in-person classroom instruction, and I remain hopeful about the status of our public health this fall.

On another topic, rent assistance remains available to help eligible low-income households with their past due, current and future rent and utilities. More at oregonrentalassistance.org.

As you know, Oregon is just days away from reaching the goal of 70% vaccination rates that will allow our state to re-open fully. Thanks to Salem Health, Santiam Health, the Oregon National Guard and the Marion County Health Department for all their hard work getting here! AUMSVILLE HISTORICAL SOCIETY

Recently Aumsville Historical Society had an inquiry about Crawford School, so the file in the museum library was examined. Crawford School was established in 1904. This is late when compared with Aumsville and West Stayton, both of which were organized in 1861. Crawford School was located southwest of Aumsville on what is now the south east corner of the Cascade High and Junior High School campus at Marion Road and 70th. Crawford School consisted of a single classroom with an attached entryway roof on the north side and a shed-like extension on the south. The shed housed a hand pump above a water well and was the base of the belfry. It is assumed that there was a wood-fired stove in the classroom. The teacher taught first-through-eighth grade. In 1945 there were about nineteen students. In 1946 there were four graduates, all girls. The teacher at that time was Mrs. Rice. Although there is an old photo which shows a bicycle leaning against the building, most students probably walked to school. When consolidation took place, the students were sent to one of the nearby elementary schools. The old school was demolished about 1957.



On May 7th, a group of student volunteers and their advisor from Cascade Junior High came to Aumsville Cemetery to clean prior to Memorial Day. The damage done by the ice in February had been taken care of by workmen, but cemeteries always need weeding and touching up. AHS President Ted Shepard told the students about the history of the cemetery. Their assistance in maintaining the cemetery is greatly appreciated.

The AHS Museum opened to the public on June 5th. Except for July 3rd, it will be open on Saturdays, from 11 AM - 2 PM until November. For other information about AHS, please contact Ted Shepard at 503-749-2744.

The AHS Museum is located at 599 Main St., directly in front of City Hall.

AUMSVILLE CITY COUNCIL MINUTES

The following may not be complete minutes from these meetings. You can find the full approved minutes on our website at www.aumsville.us/city-council.

AUMSVILLE CITY COUNCIL Minutes – May 10, 2021

Mayor Derek Clevenger called the meeting to order at 7:03 PM via Zoom Conferencing. Councilors present were Nico Casarez, Angelica Ceja (arrived at 7:06 PM), Doug Ecclestone, Scott Lee, Della Seney, Walter Wick, and Mayor Derek Clevenger. Council absent: none. City Administrator Ron Harding (CA Harding) and Office Assistant Elaina Turpin (OA Turpin) were also present via Zoom. The meeting was video recorded to be released later.

VISITORS AND PUBLIC COMMENT:

There were four online attendees and no public comment. Login information was provided for members of the community to make public comment at this time and listen to the discussion.

NEW BUSINESS: Council unanimously approved Resolution No. 07-21 A RESOLUTION AUTHORIZING AND SUPPORTING THE CITY OF AUMSVILLE APPLICATION FOR A TRANSPORTATION AND GROWTH MANAGEMENT PLANNING GRANT. CA Harding stated that this grant will cover updating our Transportation Systems Plan and integrating land use actions into transportation. Harding discussed Interchange Development Zone issues which updating our plan could help address.

Council reviewed and unanimously approved the Community Directional Sign Project. CA Harding explained that the sign project had been an item of discussion at the council planning sessions which was tabled when the ice storm forced the cancelation of the meeting. The city recently had a request from a local business regarding this type of signage. Council reviewed conceptual drawings. Mayor Clevenger wanted to see if this project could be produced in partnership with Cascade High School shop class. CA Harding replied that he had been in dis-

cussions with the teacher as to the capacity of the school to produce it. Council's preference is that the school district is involved in the project.

Council reviewed and unanimously approved the Memorandum of Understanding (MOU) with the Aumsville Exchange Club. CA Harding explained that the Aumsville Exchange Club would be assisting with the Saturday Market and Corn Festival. The MOU is a formal agreement with the Exchange Club to volunteer 200 service hours and the city will pay \$2,500 for their services.

City Administrator Report: COVID-19 cases in Aumsville increased 18 since last reporting.

CA Harding reported the following:

- The city is moving forward with Corn Festival planning.
- We are working with our State and Federal representatives on our water and sewer system needs.
- The Dog Park is on schedule and fencing will be in soon.
- The Community Center Kitchen Remodel: materials are ordered, and we are in the process of getting the space ready.
- The wheelchair swing space has been prepped.
- The emergency declaration from the winter storm was signed by the President. We can work on recovering some of the costs from the damage.

MAYOR/COUNCIL REPORTS AND INITIATIVES:

Mayor Clevenger reported that he and CA Harding met with Senator Merkley's office regarding our water/wastewater projects. Clevenger testified in front of the state legislature regarding our position with our wastewater system. Clevenger spoke with Representative Moore-Green regarding our projects, and emailed Senator Patterson's office also. They are invited to attend the Saturday Market.

The meeting adjourned without prejudice at 7:33 PM

Minutes – May 24, 2021

Council President Angelica Ceja called the meeting to order at 7:00 PM via Zoom Conferencing. Council present were Councilors Nico Casarez, Angelica Ceja, Doug Ecclestone, Scott Lee, Della Seney, and Walter Wick. Council absent: Mayor Derek Clevenger. City Administrator (CA) Ron Harding and City Clerk (CC) Colleen Rogers were also present via Zoom. The meeting was video recorded to be released later.

VISITORS AND PUBLIC COMMENT:

There was one online attendee and there was no public comment. Login information was provided for members of the community to make public comment at this time and listen to the discussion.

NEW BUSINESS:

Council reviewed the G3 Restaurant OLCC Liquor License application. CA Harding explained the new owners of the Pizza Peddler building are applying for a full service liquor license. He also pointed out that they are wanting to do some improvements to the property and have started a Type 1B process with the city for the project. He stated that the OLCC license is what is before Council at this meeting and introduced Treva Gambs, owner of G3 Restaurant, LLC and new owner of the building at 325 Main St. She told Council how excited she is to be part of the Aumsville business community. She stated that she also owns the Gamberetti's Restaurants in Salem and Albany. They have been in Salem for 11 years and Albany just over two years. Council members welcomed her to the community and thanked her for attending the meeting. Council unanimously approved authorizing the city administrator to sign and approve the Liquor License application for G3 Restaurant at 325 Main Street in Aumsville Oregon.

Council reviewed and unanimously approved Resolution No. 08-21 A RESOLUTION ESTABLISHING WATER AND SEWER RATES FOR THE CITY OF AUMSVILLE. Councilor Ceja asked for Public Comment. There being none, she asked for a staff report. CA Harding stated this is our annual programmed 3% inflationary increase. He explained that this was part of our Budget Committee discussion as part of our fiscal policy plan. This resolution is the final step in the budget approval process.

Council reviewed and unanimously approved Resolution 09-21 A RESOLUTION ESTABLISHING UPDATED CITY SERVICE FEES AND PUBLIC RECORDS/INFORMATION REQUEST POLICY. Councilor Ceja asked for Public Comment there being none, she asked for a staff report. CA Harding explained staff is recom-

mending two changes to the fee schedule. Staff proposed that all business licenses will now have a fee of \$25 for the first year, with a \$10 renewal, and a one year expiration. Staff also proposed eliminating the interpreter fee from the court fees section.

Council reviewed and unanimously approved the GSI Proposed Sub-consultant Services for Westech Engineering to complete Task 4 and 5 as described in the proposal not to exceed \$30,550, from the water system development fund 024-800.

Council reviewed and unanimously approved the purchase of two Public Works vehicles as described from fund 020-810 in the amount of \$74,583.53. CA Harding reported that both vehicles will be 4x4 which was identified as a need after the ice storm in February. He explained that it also fully equips the Public Works

department with vehicles for each employee that works independently most of the time.

City Administrator Report: CA Harding informed Council that we will not be renting out the community center due to the kitchen remodel that is still in the works. Reservations for the Porter-Boone Park shelter have also been on hold. With the recently updated COVID guidelines, staff will be revisiting opening reservations again.

Councilor Casarez inquired about the current US Census results and how it could affect the amount of grant dollars that the city would qualify for to buy down the cost of the necessary updates to our wastewater treatment system and it was discussed.

The meeting adjourned without prejudice at 7:41 PM

WEEDS AND INVASIVE VEGETATION

You, as the homeowner or tenant, are responsible for clearing weeds and noxious vegetation all the way through the right-of-way—to the curb line or street. Ordinance 686, Section 9 defines Noxious Vegetation as:

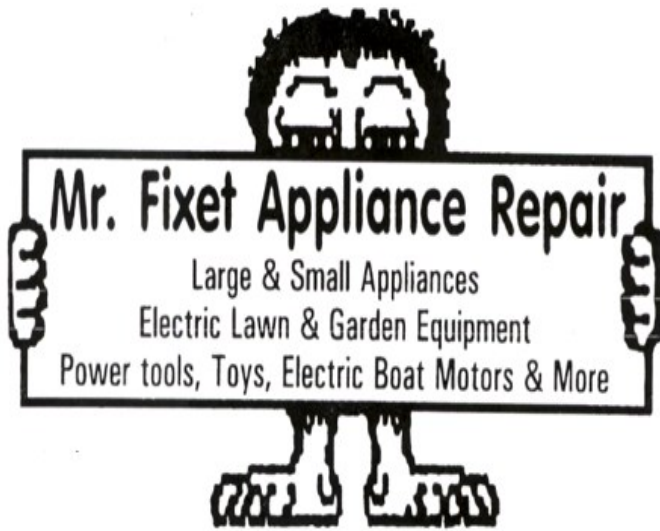
- Weeds more than 10 inches high
- Grass more than 10 inches high
- Poison oak/ivy
- Blackberry bushes, or any berry, that extends into the street or sidewalk, or across a property line
- Scotch broom and other non-native, invasive vegetation

An owner, or person in charge of the property, must cut down or destroy these weeds and vegetation to prevent them from becoming a fire hazard, or if a weed—going to seed. You must maintain your yard in a manner which is not unsightly, meaning you need to keep it clean and tidy. You also cannot allow any plants to impair the view of either pedestrians or vehicles. This could cause an accident. This means no plantings higher than 36 inches tall at street or driveway intersections. And for trees in this area, the branches need to be trimmed to above 8 feet.

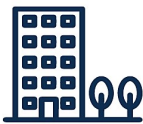
