As many in our community are aware, the City has been working diligently to get grants to assist us with our Wastewater system project required by DEQ. Many of you have been engaged with the city and have helped support our grant request with support letters.

I am very happy to announce that we were successful in receiving 5 million dollars from the Oregon State Legislation in this session. Your support was vital in helping us receive these funds because we

were able to show our community was engaged in the issue and concerned about our ability to maintain affordable utility rates.

We asked for \$15 million and would have loved to receive the full amount but \$5 million will go a long way, and this award along with previous grants will pay for about 30% of the funding.

I want to thank Senator Fred Girod and Representative Ed Diehl for all their work this legislative session. I also want to thank Governor Kotek for visiting and understanding our issues that affect affordable housing.

We're not done: the City will continue to look for additional grant opportunities and we have done a good job of positioning the City for some grants in the form of loan forgiveness. There is no guarantee, but we are hopeful we can position the City to receive an

additional \$5-8 million in grants during the loan stage of this project. This should provide funding for more than 50% of the project.

Finally, let me thank our community for stepping up to help. It's a very powerful statement to say to our state and federal representatives that our community is engaged in this issue, and we are working together to meet the state requirements while making this project sustainable for our community.

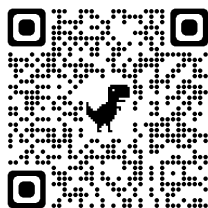

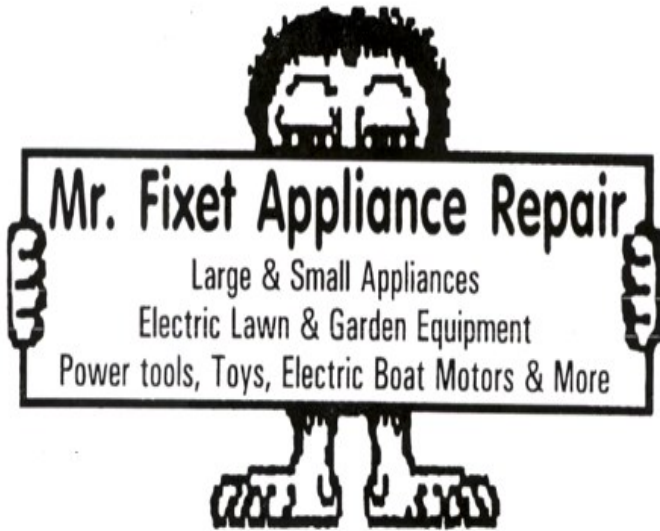

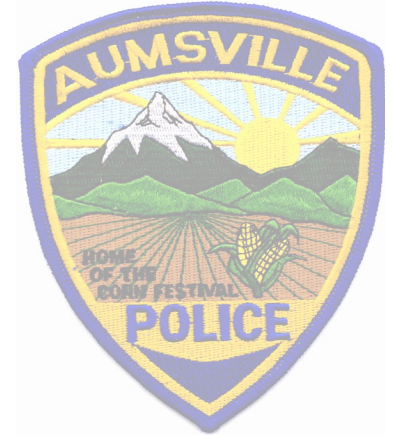
DEPARTMENT MESSAGE:

June 12, 2023 City Council Minutes

Mayor Angelica Ceja called the meeting to order at 7:05PM. Present in-person were Mayor Angelica Ceja, Councilors Della Seney, Douglas Cox, Katie Wallace, and Walter Wick. Council absent: Nico Casarez and Scott Lee. Staff present: City Administrator (CA) Ron Harding, Finance Officer (FO) Joshua Hoyer, Police Chief Damian Flowers, and City Clerk Traci Nichols.

PUBLIC HEARINGS:
 Certifying Municipal Services and State Revenue Sharing Hearing. Mayor Ceja opened the Public Hearing at 7:07PM. FO Joshua Hoyer addressed Council, illustrating the steps involved in the City's election to receive State Revenues, which includes certifying certain municipal services. No member of the audience wished to provide comment. Mayor Ceja closed the Public Hearing at 7:08PM. Council present unanimously approved Resolution 4-23 – Certifying Municipal Services, and Resolution 5-23 – Declaring the City's Election to Receive State Revenues.

Fiscal Year 2023-2024 Budget Hearing. Mayor Ceja opened the Public Hearing at 7:10PM. FO Hoyer spoke to Council, explaining the Budget process to this point. No members of the audience wished to provide comment. Mayor Ceja closed the Public Hearing at 7:12PM. Council present unanimously approved Resolution 6-23 – Adopting the 2023-2024 Fiscal Year Budget in the amount of \$21,000,232 and levying taxes at the permanent rate of \$3.6327 per \$1,000 of assessed value.

Defining Nuisances and Amending Ordinance 686 Hearing. Mayor Ceja opened the Public Hearing at 7:13PM. City Administrator Harding addressed Council, explaining that court cases and appeals had led to the adoption of House Bill (HB) 3115. Under HB 3115, the City needs to have a plan to accommodate homeless persons that may dwell within the City. The City's approach to this is to preserve and protect quality-of-life areas: residential neighborhoods and parks. All 3 ordinances before Council must be adopted to be compliant with the new rules in HB 3115. No members of the audience wished to provide comment. Mayor Ceja closed the Public Hearing at 7:24PM. Council present unanimously approved Ordinance 713 – An

Ordinance Amending Ordinance 686 – The Nuisance Ordinance.

Regulating Use of Public Spaces and Amending Ordinance 691 Hearing. Mayor Ceja opened the Public Hearing at 7:25PM. CA Harding addressed Council, indicating the staff report for this Ordinance was basically the same as the last. No members of the audience wished to provide comment. Mayor Ceja closed the Public Hearing at 7:27PM. Council present unanimously approved Ordinance 714 – An Ordinance Amending Ordinance 691 – The Parks and Public Spaces Ordinance.

Regulating Camping on City Property and Prescribing Penalties Hearing. Mayor Ceja opened the Public Hearing at 7:28PM. CA Harding indicated this was a new Ordinance, describing conditions under which camping spaces could be occupied and where they are prohibited. No members of the audience wished to provide comment. Mayor Ceja closed the Public Hearing at 7:31PM. Council present unanimously approved Ordinance 715 – An Ordinance Regulating Camping and Prescribing Penalties.

NEW BUSINESS:
 Resolution 7-23 – A Resolution Establishing Water and Sewer Rates for the City of Aumsville. CA Harding addressed Council, explaining the need to increase water and sewer rates. The Resolution holds a 5% increase in water and an 8% increase in sewer rates, which is a net effect of 6.5% to monthly utility bills. Council present unanimously approved Resolution 7-23.

Westech Engineering Contract Amendment. CA Harding addressed Council, explaining this contract amendment added American Rescue Plan Act (ARPA) clauses. Adding these clauses complies with new rules and will prevent delays in grant funding. Council present unanimously approved the amendment of the contract with Westech Engineering.

Resolution 8-23 – A Resolution Extending the City of Aumsville's Workers' Compensation Coverage to Volunteers of the City of Aumsville for Policy Year 2023-2024. CA Harding explained this is a Resolution that needs to be adopted each year to extend Workers' Compensation coverage to City

volunteers. Council present unanimously approved Resolution 8-23.

CITY ADMINISTRATOR REPORT:
 CA Harding said the Police Department had been much more active. He said the Public Works Department had been busy with numerous projects and City events, as well as wastewater facility training and other certifications. Superhero Carnival is on June 24th, which is a free event for the community. It coincides with the first Saturday Market.

CA Harding met with Salem-Keizer Area Transportation Study (SKATS) and discussed how the process of moving Aumsville into the Metropolitan Planning Organization (MPO) is coming along. Councilor Seney indicated she could be a City representative for the committee, as it's part of her Transportation Commission duties. Councilor Cox indicated he would be happy to be a back-up. Council present unanimously approved Councilor Seney as the City's representative, with Councilor Cox as back-up if needed.

Corn Festival Grand Marshal nominees have been accepted. The well drilling project at Porter Boone Park is beginning, and community notices have been sent out.

MAYOR/COUNCIL REPORTS AND INITIATIVES

Councilor Seney attended the Mid-Willamette Valley Areas Commission on Transportation (MWACT) meeting. Salem Cherriots and Yamhill Transportation both received replacement bus funding. Monmouth/Independence receiving funding for their trolley. Mayor Ceja addressed the League of Oregon Cities (LOC) Summer Conference. CA Harding said that as soon as reservations open, they are immediately booked, so it was important to move quickly. The conferences are valuable for not only networking, but the educational components as well. Mayor Ceja indicated she would be attending the Oregon Mayors Association (OMA) Conference in August [in Hood River]. CA Harding advised the City has budgeted for training, travel and mileage reimbursement for Council.

Mayor Ceja adjourned the meeting without prejudice at 8:11PM.

The temperature of stormwater runoff into our creeks and streams can be reduced by you! 6 years ago the City of Aumsville joined Tree City USA. We have adopted a Street Tree ordinance requiring street trees to be planted in new developments and existing street trees are required to stay unless they are dangerous or creating a hazard.

These street trees aren't only for the beautification of our community but they also serve a very important purpose of lower temperature in spring and fall stormwater runoff. The fall and spring

stormwater runoff can have a damaging impact on aquatic life and the ecosystems in the area's streams and creeks. Simply planting a tree can not only add to the landscaping of your property but also, help the city reach its goals of lowering the temperature in our waterways. This is one of our TMDL strategies for lowering the temperature in our stormwater.

This month the City will make a Facebook post about newly planted trees and we would love to see a newly planted tree that helps lower temperature, adds beauty, and cleans the air in our community. We will have a prize for the best picture. We hope you can join us in doing our part to lower the temperature of the stormwater in our watershed.
