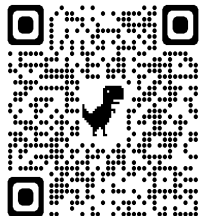
Do you have a small business or crafting hobby?

The 2023-2024 budget was approved by the Budget Committee on May 13th, and will be adopted with minor adjustments at the June Board meeting. The Fire District maintains a minimal budget that has not required additional levy funds since 2016. The Fire District is in sound financial condition.

This early dry spell does not bode well for the fire season. Please use caution when burning yard debris, using barbecues, or recreational fire pits.

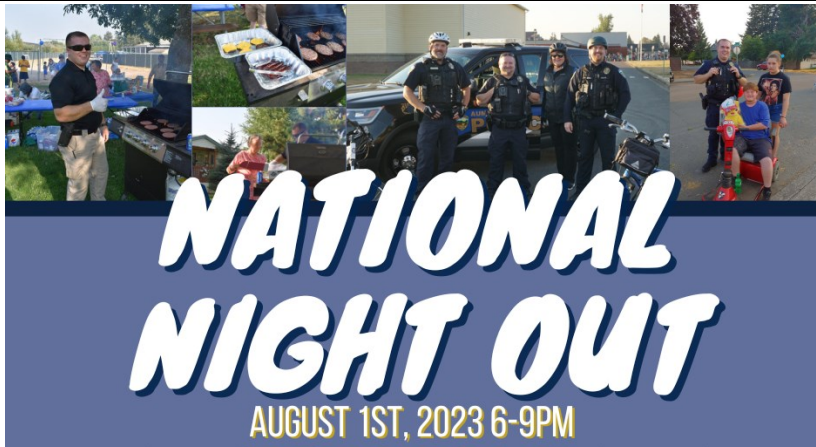
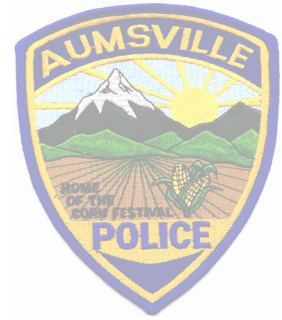
DEPARTMENT MESSAGE:

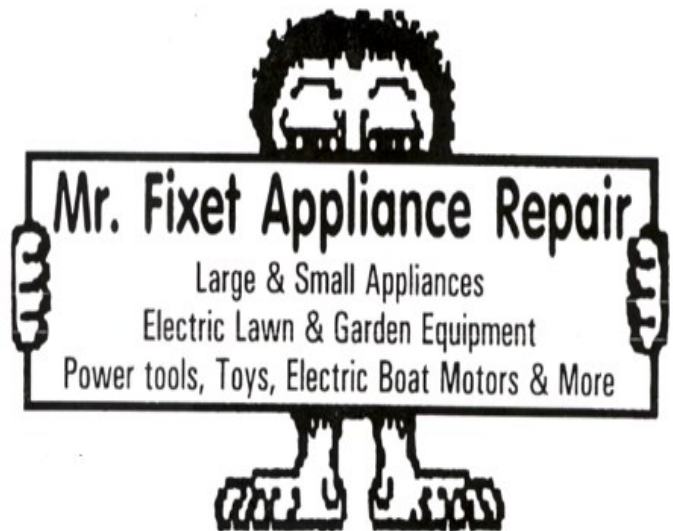

STATEMENT OF CHANGES IN ACTIVITIES and SOURCES OF FINANCING

Personal Services includes a 6% cost of living adjustment (COLA), PERS contribution rate increases, and city-paid medical insurance premium increases effective January 2024. Collections include utility rate increases to take effect July 1, 2023; 5% in Water and 8% in Sewer Funds. The Police Fund continues to experience between 5% and 10% increases in regional dispatch and records management services. The Park Fund is proposed to receive all of the State Revenue Sharing Apportionment this year, as well as a General Fund transfer to help support park maintenance costs. A General Fund transfer to the Investing In Aumsville Families & Children Fund is proposed to continue the youth programs for the year. In the System Development Charge (SDC) Funds, an estimate of up to 74 EDUs could be submitted for permits during the coming fiscal year, as the available buildable lands continue to proceed through the site development review and planning processes. The City continues to utilize various awarded grants, including \$3,557,000 for water improvements; \$1,928,440 for sewer system improvements; and \$900,000 for a new Public Works facility.

Backflow testing is required by state law

Backflow testing is an important public health water safety standard. I've been told by more than one person that the inspectors are a money racket for them and the city. Well, it is not a money-grabbing program for the either. In fact, the cost to have Backflow Specialists that are trained to identify plumbing-related hazards, hydraulics and proper placement of approved backflow assemblies to protect the public water supply is relatively low compared to hiring a plumber. The city doesn't get any money from backflow inspection. We have to administer this for free.

Irrigation systems are usually underground plumbing with sprinkler heads that can be contaminated with a lot of different chemicals, such as pesticides and fertilizers. Animal waste, bugs, larva, worms, etc. can also make a way into an irrigation system. This water has the potential to flow into our public water supply in certain conditions. This is the reason the federal, state, and city governments require backflow prevention on irrigation systems.

Today, the city tracks over 462 backflow assemblies. It takes ¼ of a full-time employee's time to keep up with inspections and making sure all these backflow assemblies are tested every year. Reminders, second notices, shut off letters, paper, envelopes, and postage as well as the cities time, and the city does not make a penny back on it. It is so important to keep our city water safe for all. That's what it's all about.

If you have installed an irrigation system without backflow protection, you are putting yourself and others, in your community, at risk of water contamination. So, if you did, you need to make it right. I'm NOT here to be the "Bad Guy", I am here so you can have the information you need to make it right. Please feel free to give me a call and see what you need to do to prevent a potential incident.

Why We Ask You to Apply for a "Type A" Permit with the City

The Purpose of Building Permits, no matter what kind of job you're completing, it's important that you have the right building permits to do it.

The city does not charge for a "Type A" permit, but if a permit involves electrical, mechanical, or structural work, a Marion County Building Permit may be required. The city helps facilitate this process.

Safety: The main purpose of any building, structure or electrical permits is to ensure safety. By enforcing proper safety standards, you and other occupants of a space have a better chance to avoid any accidents or issues during the construction process.

Save You Money: Many people are swayed away from proper residential building permits because of the lengthy process, but it could cost much

more in the long run. We can process a "Type A Permit" usually in a day or two. Below are examples of what the city checks for:

- There may be a utility easement on your property you are not aware of.
- Setbacks from property lines.
- Size and height restrictions for accessory structures and fences.
- Number of structures allowed.
- Architectural requirements.

If you build a shed, add concrete, or add on to your house and it does not meet the city development code, you will have to move or remove the project.

May 8, 2023 City Council Minutes

Mayor Angelica Ceja called the meeting to order at 7:00PM. Present in-person were Mayor Angelica Ceja, Councilors Scott Lee, Della Seney, Katie Wallace, Douglas Cox and Walter Wick. Council absent: Nico Casarez. Staff present: City Administrator (CA) Ron Harding, Assistant Public Works Director (APWD) Matthew Etzel and City Clerk Traci Nichols.

NEW BUSINESS:
TAG: Integrator of Record – A request for proposals was sent out a few months ago to find an integrator of record. This is an entity that handles the City's telemetry work for the Wastewater Treatment systems and all the City's monitoring and automation. There is a lot of computer logic going into the systems used, and having one company with backups of the City's systems is very helpful. If something happened in the middle of the night, the City could call TAG who could remotely troubleshoot problems within the systems. TAG was the only entity who responded to the request for proposals, and Council unanimously voted in favor of authorizing the City Administrator to enter into contract with them.

Boone Well #3 and Mill Creek Well #1 Drilling Project – The City identified Porter Boone Park and Mill Creek Park as sites for 2 new City municipal wells. The project was sent out for bids, and the low bidder was Jones Drilling Company. Drilling would be done in Porter Boone Park through the summer, and hopefully end by the fall or winter. Drilling in Mill Creek Park can be done in the winter because it's closer to the asphalt. The City transferred some water rights that were no longer beneficial in order to drill the new wells. Council unanimously voted in favor of awarding the project to Jones Drilling Company.

CITY ADMINISTRATOR REPORT: CA Harding reminded Council of the Budget Committee meeting the next evening. He indicated he would like to complete the budget process in one meeting, following the City's previous trend. CA Harding advised Council the budget would be brought before Council for adoption on June 12. CA Harding advised Council of an Executive Session on May 11th which would be a quick discussion on where the City is in contract negotiations, and to obtain guidance from Council on where to go from there. CA Harding said there were

several actions going forward from now until the end of June: multiple ordinances, Park Master Plan updates and several contracts. CA Harding encouraged Council to think of names for Corn Festival Grand Marshal and submit those to Staff.

MAYOR/COUNCIL REPORTS AND INITIATIVES: Mayor Ceja and Councilor Seney had gone to the Ways and Means Committee meeting to speak on the City's capital funding request. They had already spoken in a different meeting the Wednesday prior, so were not called to speak. They had submitted the community letter of support with citizen names and addresses. Mayor Ceja was impressed with the response from the community in signing the petition.

GOOD OF THE ORDER: Councilor Wallace attended an event with a great community response. Councilor Seney said the Arbor Day event at the elementary school went well. Tree saplings had been handed out to students during the event, and many families reported back on where they had planted the trees.

Mayor Ceja adjourned the meeting without prejudice at 7:17PM.
