Aumsville Historical Society News



A recent addition to the Aumsville Historical Society Library is OREGON'S SEACOAST LIGHTHOUSES by James A. Gibbs with Bert Webber. It contains the detailed history of the fewer than 15 lighthouses that have been on the Oregon Coast and biographical information about the founders. Each lighthouse was different from the others. In the era of wind propelled ships, there were many dangers including rain, fog wind, and lack of wind,. Many ships were

wrecked; others simply disappeared. Lighthouses provided a lifesaving beacon for those at sea and in some cases, a fog horn. The first lighthouse on the Oregon and Washington coasts was at Cape Disappointment on the north side of the Columbia River. It was constructed in 1856 on a headland 229 feet above the water. In spite of its commercial importance to Oregon, that location is now in Washington State. Early lighthouses had oil burning lights. Beginning in 1937 electricity was installed in the Oregon lighthouses. The oldest lighthouse on the Oregon Coast is at Cape Blanco near Port Orford. It is built in 1870. Its light could be seen from 22 miles at sea. The Yaquina Bay Lighthouse near Newport was

built in 1871, closed in 1874. Its frame building has been restored; it is the oldest standing building in the area. A non-profit organization oversees this showplace in a park. Since the Gibbs book was published in 1992, it does not include the events of the past thirty years. Modern technology has replaced the lighthouses, but their locations offer visitors wonderful scenery and native wildlife. Several have visitors' centers. Others are privately owned. AHS will meet at 6:30 pm November 10th in the community center.

The museum is closed for the winter. To visit by appointment, please phone Ted Shepard @ 503 -749-2744.

Good Day, neighbor!

The backyard burn season was delayed due to unusually dry late fall weather. We received several calls reporting agriculture fires during that



time, and those burns were authorized and carefully monitored by the Department of Ag. Burns of that nature are referred to as “test fires” and the data collected such as smoke behavior etc. determines how future field and logging slash burn permits are issued.

As we get into colder weather, we anticipate more and more use of wood stoves and fireplaces, which occasionally leads to chimney fires or overheated appliances. Please make sure your chimneys are maintained properly and use caution on the amount of fuel you add to your appliance. Modern wood appliances are very efficient and typically don't require the fuel load of older appliances. Chimney fires often require rooftop operations for firefighters which are extremely risky, particularly in icy weather.

When energy costs rise, people often turn to alternate means of heating their home. Remember, it is NEVER a good idea to attempt to use any appliance that produces carbon monoxide to heat an enclosed living space, for humans or animals. Propane and kerosene space heaters can be deadly in certain circumstances.

The 3 seasonal firefighter positions funded by the Office of the State Fire Marshal ended on October 15, so the department is currently at minimum staffing. These seasonal positions were a huge asset to our summer staffing and proved their worth on several incidents throughout the District, as evidenced by the various blackened patches of foliage scattered across the area. We are applying for additional personnel grants to further enhance our staffing capabilities.

There are some great events coming up. The District Turkey Shoot Bingo will be held on November 19th here at the main station. We were unable to obtain a gaming permit on time this year, so the volunteers will hold this event for “donations per game” instead of selling bingo cards. We are confident our community will support us in this important annual event. Come one, come all and get your game on! We are also planning our Christmas Open House on December 10th. The District Link Support Team is planning a special event called, “The 12 days of Christmas.” Instead of searching for painted rocks, you could get some cash! Look for the announcement in this newsletter. Stay safe, my friends.

2022 ELECTION MEASURE INFORMATION

On August 8th, 2022 City Council voted to refer the question to voters for the following measures:

CITY OF AUMSVILLE BALLOT MEASURE 24-470

CAPTION: Prohibits psilocybin-related businesses within Aumsville

QUESTION: Shall Aumsville prohibit psilocybin-related businesses from operating in the City?

SUMMARY: State law allows for the manufacturing, transportation, delivery, sale, and purchase of psilocybin, the psychedelic drug found in certain mushrooms. State law provides that a local government may adopt an ordinance to be referred to the voters to prohibit the establishment of licensed psilocybin product manufacturers and/or psilocybin service centers.

The Aumsville City Council adopted an ordinance to refer to the voters prohibiting psilocybin-related businesses from operating in Aumsville. Approval of this measure would prohibit the establishment of psilocybin product manufacturers and psilocybin service centers within the Aumsville city limits.

Explanatory Statement:

Approval of this measure would establish a prohibition on psilocybin product manufacturers and psilocybin service centers within the City of Aumsville. Psilocybin is the psychedelic drug derived from certain mushrooms. Oregon voters legalized psilocybin through Ballot Measure 109 in 2020, which directs the Oregon Health Authority to develop a psilocybin licensing and regulatory program for the state by January 2, 2023.

Ballot Measure 109 allows a local government to adopt an ordinance to be referred to the voters that prohibits the establishment of psilocybin-related businesses. The Aumsville City Council has adopted such an ordinance.

CITY OF AUMSVILLE BALLOT MEASURE 24-471

CAPTION: Allows certain marijuana-related facilities within Aumsville

QUESTION: Shall Aumsville allow medical marijuana dispensaries, marijuana retailers, marijuana processing sites, marijuana producers, marijuana processors, and marijuana wholesalers in the City?

SUMMARY: State law allows for the operation of registered medical marijuana processors and dispensaries as well as for the operation of OLCC-licensed recreational marijuana producers, processors, wholesalers, and retailers.

State law also permits the voters of a city to adopt an ordinance that prohibits the establishment of any of these registered or licensed facilities within the city.

Aumsville voters adopted Ordinance 644 in November 2016 prohibiting such registered and licensed facilities within City limits. If approved, this measure would repeal and replace Ordinance 644 to allow registered medical marijuana dispensaries, marijuana retailers, medical marijuana processing sites, marijuana producers, marijuana processors, and marijuana wholesalers to operate within the City. Such facilities would still have to comply with other applicable laws, such as zoning code requirements.

Explanatory Statement:

Approval of this measure would allow registered medical marijuana dispensaries, marijuana retailers, medical marijuana processing sites, marijuana producers, marijuana processors, and marijuana wholesalers to operate in the City of Aumsville. State law allows for the operation of registered medical marijuana processors and dispensaries as well as for the operation of OLCC-licensed recreational marijuana producers, processors, wholesalers, and retailers.

Aumsville voters approved a ban on medical marijuana processing sites, medical marijuana dispensaries,

marijuana producers, marijuana processors, marijuana wholesalers, and marijuana retailers on November 8, 2016, which was enacted as Ordinance 644.

Under ORS 475C.457, a city council may repeal an ordinance that prohibits the establishment of certain types of marijuana-related businesses in the city, or the council may submit this repeal to the voters of the city. As such, the Aumsville City Council has referred this measure to the voters, which will effectively repeal Ordinance 644 and replace it with a new ordinance that will allow for the operation of registered medical marijuana dispensaries, marijuana retailers, medical marijuana processing sites, marijuana producers, marijuana processors, and marijuana wholesalers in the City.

If this measure passes, the City will be eligible to receive state marijuana tax revenues. If passed, this measure will go into effect 30 days after its approval by the voters.

CITY OF AUMSVILLE BALLOT MEASURE 24-472

CAPTION: Authorizing tax on recreational retail sales of marijuana items

QUESTION: Shall Aumsville impose a tax on the sale of marijuana items sold by recreational retailers as permitted by state law?

SUMMARY: Under state law, cities may adopt ordinances imposing up to a three percent tax or fee on the sale of recreational marijuana items in the city by state-licensed marijuana retailers as long as the ordinance is referred to the voters for approval at the next statewide general election. This measure seeks the required voter approval for the City to impose a tax on the retail sale of all marijuana items sold by an OLCC licensed marijuana retailer in the City in an amount equal to the maximum allowed by state law, which is currently equal to three percent.

If this measure is approved, the City would be authorized to impose a three percent tax on recreational marijuana sales in Aumsville and increase the amount of the tax if and when state law permits such increases.

Explanatory Statement: Approval of this measure would impose a three percent tax on the sale of marijuana items by a marijuana retailer within the City and permit increases in the amount of the tax if and when state law permits such increases. Under Measure 91, adopted by Oregon voters in November 2014, codified in ORS chapter 475C and amended by the Legislature, the Oregon Liquor Control Commission (OLCC) must license the retail sale of recreational marijuana. ORS 475C.453 provides that a city council may adopt an ordinance imposing a tax or fee on marijuana items (which include marijuana concentrates, extracts, edibles, and other products intended for human consumption and use) sold in the city by retailers licensed by OLCC, but the council must refer that ordinance to the voters at a statewide general election. The Aumsville City Council adopted an ordinance imposing a tax in an amount equal to the maximum permitted by state law on the sale of marijuana items by a retail licensee in the City, and, as a result, has referred this measure to the voters.

Under state law, if the City prohibits the establishment of medical marijuana processors, medical marijuana dispensaries, recreational marijuana producers, recreational marijuana processors, or recreational marijuana retailers, the city may not impose a tax or fee on the sale of recreational marijuana. The Aumsville City Council has also referred to voters for the November 8, 2022 election, a measure to allow these facilities in the City. The tax proposed by this measure will be collected only if the City does not have a prohibition in place on any of the marijuana facilities described above. In effect, if the voters do not approve the measure to allow these types of marijuana facilities in the City, this tax measure will not go into effect.

If approved, the tax would be paid by anyone buying recreational marijuana from a licensed retailer located in the City regardless of whether they are an Aumsville resident or not. The current tax rate would be equal to three percent of all retail sales and could be increased if and when state law permits such increases.

September 26, 2022 Meeting

The meeting was called to order at 7:03 PM. Present in-person were Councilors Casarez, Ceja, Lee, Seney, Wick, and Mayor Clevenger. Staff present: City Administrator (CA) Harding, Public Works (PW) Assistant Director Etzel, and City Clerk Rogers. Council absent: None. The meeting was video recorded to be released later.

PRESENTATION: PW Assistant Director Matt Etzel presented Council with an update on the Total Maximum Daily Load (TMDL) implementation plan. He explained that the city must send an annual report by February 28th of each year. In February this year Environmental Protection Agency (EPA) notified the Department of Environmental Quality (DEQ) that they were implementing a final revised Willamette Basin Mercury TMDL. Matt summarized how the additional requirements of the revisions will affect the city. Staff will be working on updating ordinances and securing funding to comply to the requirements and bring them to Council for approval.

Aumsville resident, Ty Weber, addressed Council regarding an accident on Mill Creek Road, where a student waiting for the school bus was struck by a vehicle. He wanted to make Council aware of the incident and asked that they work to make areas safer where kids are waiting for the bus. Councilor Seney cited that the biggest obstacle with Mill Creek Road is that it is a county owned road and they set the speed limit and crosswalk locations, and it was discussed. Mayor Clevenger thanked Mr. Weber and assured him that Council will work with Marion County to find a solution. Council unanimously approved the September 12, 2022 city council meeting minutes as presented.

PW Assistant Director Etzel explained that last year staff from Police and Public Works worked with Marion County Emergency Management to update the city's Addendum to the Marion County Multi-Jurisdictional Hazard Mitigation Plan. Our old plan expired on August 16th, 2022. The renewal of this plan gives the city eligibility for FEMA Hazard Mitigation Assistance funding.

CA Harding reported that the Aumsville Police Department has been operating with the use of two main patrol vehicles, and one limited use patrol vehicle due to wear and tear. He explained that having just the two patrol vehicles for the multiple shifts per day, quickly runs these vehicles up in mileage and wear and tear. Adding a 3rd vehicle, would spread out the mileage use, and decrease the number of services and repairs needed for upkeep. Three shifts per day, for seven days a week, is a lot of wear and tear to be split between only two vehicles. This would also afford us the ability to have enough patrol vehicles in the event one gets damaged or needs a lengthy service repair.

CA Harding informed Council that the city has developed a vehicle replacement schedule and have been saving funds in a vehicle replacement program for this purpose. We currently have the funds in the vehicle replacement fund to purchase an upfitted patrol vehicle outright to supplement our patrol fleet.

Council unanimously voted to authorize the city to purchase a new patrol vehicle fully equipped using the state contract prices and small bids for \$62, 876.43 from fund 020-811.

CA Harding announced that on October 15th staff are planning a fun community event. The Great Pumpkin Walk will be free to attend, and everyone gets a free pumpkin to take home.

Council unanimously voted to accept Councilor Ecclestone's resignation due to him moving out of the city. Council discussed how they would like to fill the position. The term for this position expires December 31, 2024. It was decided to open applications now and appoint at the first January meeting in 2023.

Mayor Clevenger adjourned the meeting without prejudice at 7:27 PM.
