Letter from the Mayor



Hello Aumsville,

I wanted to take a moment to share a few things. I can hardly believe it's already October. It so happens that for many reasons, October is my favorite month of the year. One of them is the celebration of Día de los Muertos. Similar to Halloween, it's celebrated with candy, food, and visits to gravesites. The biggest difference would be the building of "ofrendas" or alters, for family and loved ones that have passed.

By now schools should be back in full swing, and the city is gearing up for holidays and the end of the year. I recently met with our neighboring Mayors from Stayton, Sublimity and Turner to talk about the Oregon Mayor Association annual "If I were Mayor" contest for students. My goal was to see if we could collaborate with one another to promote the contest. Our towns residents share the schools of St. Mary's, Regis High School, Cascade Jr High and High School. As of right now we are in the planning stages of this contest. Trying to figure out what prizes would best motivate students to participate. I am also reaching out to the schools to see if a teacher or club would be willing to help. If you are a teacher or run a student club, please reach out to the city or me for more information.

The city has been working to get funding on 3 major projects. Our new wastewater treatment facility, drilling of a new well for drinking water, and the building of a new public works facility. If we were to cover these on our own, it would be \$34,000,000. The good news is the city has successfully received some grants. To date this is where we are with funding. We have received \$900,000 towards a much-needed new public works facility that will support city services. \$3,600,000 to build a new water reservoir that will help supply drinking water. With the help of our residents, we now have leveraged over \$17,000,000 for our wastewater facility! The city will need to take about \$11,000,000 in loans for the wastewater project. So, 65% of these projects will be funded by grants. Leaving 35%, that will need to be funded locally to pay for those loans. In terms of being able to receive this much funding, this really is great news for our community. It has been a busy year for us so far but there is still a lot of work that needs to be done. I wanted to share with all of you that our town coming together has been noticed by our state and federal leaders. As a small rural community, we needed to stand out to show why Aumsville is important and I believe we did just that! It is ok to be proud of yourselves. I am excited to see what this next year brings for our community.

We have accomplished a lot of positive progress in Aumsville over the past few years, and our staff is the reason behind

many of these accomplishments. We have been fortunate to have many staff here for years, and that seasoned experience is of great benefit to our community. As staff leave or retire we do our best to fill those positions with candidates who are talented and bring expanded skillsets to our team. Our team has leveraged over 22 million dollars in grants for our water, wastewater, and other public facilities over the past couple of years. In addition to the day-to-day management. This is an unprecedented accomplishment without which would have resulted in much larger rate increases to our residents.

This month I would like to shine a spotlight on Kirsti Pizzuto. Kirsti has been working as my executive assistant for over a year at the city of Aumsville. Kirsti has quickly become a valuable member of my team, always willing to tackle difficult projects. Often, we have to navigate through state and federal programs with not a lot of historical experience, and it takes someone who can dive into the programs, understand the requirements, and help our projects meet those requirements.

Kirsti is also bi-lingual, and that skill has allowed us to reach out to our Spanish-speaking population, engage in city issues and topics, and help in administering city services. Kirsti's wide range of skillsets would impress any manager, but it's her can-do approach to tasks and ability to follow

through that sets her apart. Kirsti has also been a key member of my team supporting, managing, and acquiring grants for our water and wastewater projects and that support has helped us leverage these grants for our community. In this role, she taught herself the operations of a wastewater plant in order to be able to engage with granting agencies and complete contract management tasks to be able to fully utilize those programs.

Kirsti's future goals are to move into a city administrator position, and to me, the ultimate compliment for any manager is to help mentor someone into their position.

Aumsville is fortunate to have staff like Kirsti Pizzuto and I hope when you are in city hall you take the time to say hi and congratulate her on a job well done.

Oregon State Fire Marshal (OSFM) urges us all to keep these important cooking safety tips in mind, especially with the upcoming holidays:

- Keep an eye on what you're cooking; don't leave cooking unattended.
- Keep your cooking areas clean and clear of combustibles (potholders, food packaging, towels, etc.) and wipe up surface spills.
- Create a three-foot kid and pet-free zone around the stove.

-Have a lid or cookie sheet in reach while cooking (to smother flames) in case of a fire.

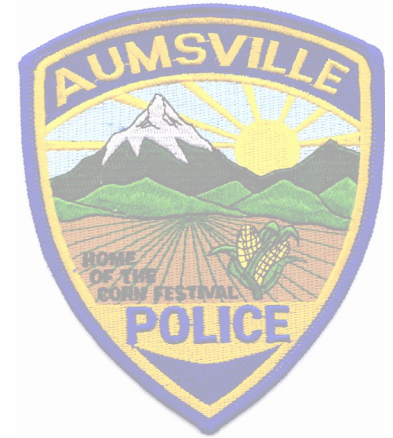
The reserves worked a total of 37.5 hours during the month of August: 37.5 volunteer hours and 0 paid hours.

The Purpose of Type-A Permits in Aumsville

Anytime you're completing a project in Aumsville or most other cities for that matter, a permit is required for electric, plumbing, and structural improvements. This is usually required by state law and the city may implement these requirements or in a smaller city, they may choose to contract with the county to complete the required inspections.

These permits are required to ensure when someone purchases a home that it's safe or not needed major reconstruction or repairs. Sometime homeowners will not get a permit and complete these projects without a profession inspection. In those cases, there are two risks for homeowners. First, we cannot be sure they have constructed something that's safe and second you have no approval for the work which means you may end up tearing down the improvement and starting over.

Locally we have always required permits for these types of projects as well as larger projects effecting the public like roads, sidewalks and utility work. But we also require a permit for fences, re-

landscaping, sheds and any similar projects, called a type A permit.

The purpose behind this permit to document that the homeowner followed the code at the time of construction, and it allows the homeowner to have knowledge that their project is approved so in the future your grandfathered into any changes that could occur. One of the largest reasons is if a resident has not obtained a permit they may also not be constructing to code, and we would rather help you understand what's required before you spend good time and money on a project that may need to be removed.

Always check with the city before moving forward with your project, this will help make sure project go much easier and provide you with piece of mind that the project has been done correctly and the permit is absolutely free.

NOTICE IS HEREBY GIVEN that on Thursday, October, 5, 2023, at 6:00 pm, the Aumsville Planning Commission will hold a public hearing regarding case 2023-09 CPMA-Eastside, to adopt an amendment to the Aumsville Urban Growth Boundary (UGB) and Comprehensive Plan map.

The City Council recently adopted Ordinance 716 which updates Chapter 6 “Recreation Element” of the Aumsville Comprehensive Plan. The previous Chapter 6 included information from Aumsville’s 1996 Parks Plan; the updated Chapter 6 references the current goals and policies of the Aumsville Parks Master Plan (updated to June 2023), including a new parks master plan map that identifies the location of the Eastside Community Park.

The proposed UGB and Comprehensive Plan map amendment will include the identified Eastside Community Park site into the Aumsville UGB consistent with the direction of the updated Aumsville Comprehensive Plan and Aumsville Parks Master Plan.

At the conclusion of the public hearing, the Planning Commission will make a recommendation to the City Council regarding the proposed amendment to the UGB and Comprehensive Plan map. The public hearing will be held at Aumsville Community Center, 555 Main St., Aumsville, Oregon.

Persons wishing to participate in the public hearing may appear in person or by representative at the dates and times listed above. Written comments may be submitted by mail to Aumsville City Hall, 595 Main St., Aumsville, OR 97325. A copy of the staff report and proposal are available for inspection at City Hall at no cost or may be purchased at a reasonable cost. The following may not be complete minutes from these meetings. You can find the full approved minutes on our website at www.aumsville.us/city-council.

Mayor Angelica Ceja called the meeting to order at 7:00PM.

AGENDA APPROVAL: Councilor Seney moved to approve the agenda as presented. Councilor Wick seconded. Council present voted unanimously to approve the agenda. Agenda approved.

CONSENT AGENDA: Councilor Seney moved to approve the Consent Agenda as presented. Councilor Wick seconded. Council present voted unanimously to approve the Consent Agenda. Consent Agenda approved.

NEW BUSINESS: New Patrol Vehicle. Chief Flowers started his presentation by reflecting on the staff report brought to council the previous year to purchase Ford patrol vehicles. Ford has cancelled the city's order for the vehicles after pushing the production date back several times. He stated the order is supposed to be entered into the 2024 year build for vehicles, but there is still no guarantee the city would receive 2024 models. Chief Flowers explained that Dodge and GM are other options he has investigated. GM has one PV (Pursuit Vehicle) they can make. GM won't be able to accept orders until May of 2024 for their Tahoe PV. Chief Flowers received positive feedback from several other police departments that use Dodge Durangos as PVs without mechanical issues arising.

Chief Flowers informed council that Keizer Police Department donated two patrol vehicles to Aumsville. There will be costs to get them ready for the city's PD to use but will help with the current need. Chief Flowers recommended council to Authorize the City to purchase Dodge Durango patrol vehicles instead of the previously approved the Durangos would be ready between 90 and 120 days, with a higher cost.

Councilor Wick mentioned he spoke to the fleet manager with Marion County Public Works about Sheriff's Office about the Durangos that the county uses and noted some issues with the transmission in the earlier models. Councilor Wick said the fleet manager told him the transmission issues had been fixed.

Councilor Lee said that he had a mechanical background that made him question the transmission issues with the earlier Dodge models as well but was unsure if the newer models had fixed them. Councilor Lee stated he trusted Chief's decision-making in what would be best for the department and the city. Councilor Cox asked if council would like to amend the motion so that the police department may have the ability to pick which ever vehicle will accommodate the departments needs best.

Councilor Cox moved to approve the city to purchase two patrol vehicles of their choice instead of the Ford Interceptors previously approved. Councilor Seney seconded. Council present voted unanimously. Motion passed.

CITY ADMINISTRATOR REPORT: CA Harding started with the Public Works Report, stating the city has been working hard to reduce the lost water in the city. The city had previously been averaging 17% lost water and has been able to reduce that to around 10%. CA Harding reminded council that the city will be trying to upgrade the meter reading program in the future to help find more opportunities to reduce lost water. Mayor Ceja asked if the city knows how much of the lost water could be from the concrete pipes in the city. CA Harding predicts that as the city continues to replace the concrete pipes, the city will continue to see a reduction in lost water over time.

CA Harding reported on Corn Festival and stated that the city was down on sponsorship donations, but that the city was able to bring in more money this year to distribute to local service groups than in previous years.

CA Harding said that the Public Works building is moving forward with prepping land while waiting for permits to come through. CA Harding said the water drilling is done in Porter-Boone Park. CA Harding informed council that the audit was underway at City Hall. And the city would receive the audit report sometime after the first of the year. CA Harding stated it is time to clean out Highberger Ditch again. The

city is avoiding issues with storm water entering the neighborhood. The ditch is a deed restriction for the homes along the ditch. The homeowners are required by DEQ to maintain the ditch. He let council know that there is a Planning Commission meeting on October 5th to address the Development Code.

CA Harding informed council that CIS, the city's insurance company, is offering insurance coverage to domestic partnerships coming up in the next open enrollment. He stated he wasn't sure on the financial impact it would have on the city, should employees utilize this benefit, but that he was open to council's feedback. CA Harding stated that the consensus was to allow it as an option for open enrollment this year.

CA Harding gave an update on the wastewater funding. Mayor Ceja asked if the city knows yet what the projected water bill will be with the funding the city currently has. CA Harding stated that the city will hire a company that specializes in figuring out how the city will pay back the loans. They will do a study and will be able to figure out the financial impact on the residents. CA Harding suggested a work session to talk more about hypotheticals on what the water rate could be. CA Harding is pleased with the grants the city has been able to obtain.

CA Harding asked the council if they would like to approve new liquor licenses within the city or leave it to city staff to approve or deny in the future. By consensus, CA Harding is able to approve the licenses in the future.

MAYOR/COUNCIL REPORTS AND INITIATIVES: Mayor Ceja met with other local mayors who have all decided to work together on the If I Were Mayor contest to collaborate with local cities.

CORRESPONDENCE: No comment on provided correspondence.

Mayor Ceja adjourned the meeting without prejudice at 7:59PM.
