After issuance of this permit, the Contractor shall give the City and all local utility companies at least 24-hour notice before commencing work. For construction involving any excavation work, Oregon Law requires the permittee to locate all underground facilities before the start of excavation and take measures to protect the facilities during construction. **Type B Permit Fees:**

Pursuant to Ordinance 704 and the Public Works Design and Construction Standards, which require permits when certain work subject to the Standards is being performed in the City, the City Council of the City of Aumsville hereby imposes a permit fee equal to five percent (5%) of City Engineer's cost estimate of the project costs.
