PARK GUIDELINES

- 1. **COVID-19** You are responsible for knowing and following whatever the current State COVID Guidelines are at the time of use. However, it is always a good idea to practice safe distancing and wash hands frequently.
- 2. **Trash** We provide reasonable containers to accommodate the needs of most groups. However, if your group generates more trash than can be safely or neatly stored, please be prepared to bag and haul away.
- 3. **Hours** Park is open during daylight hours until dark.
- 4. **Parking** Park only in designated areas. Grass and roadside parking is subject to citations and fines.
- 5. **Signs** No signs or advertisements are permitted.
- 6. **Animals** All animals must be leashed. Horses are not permitted in any city park.
- 7. **Ballfields** Please use extreme caution during wet conditions or be prepared to be responsible for serious turf or infield damage. Fields may sometimes be reserved or may be used on a first-come basis as available.
- 8. **Cleanup/Damage/Security** If necessary, charges will be assessed for any cleanup or repair exceeding the routine. Please make every effort to keep the area clean, safe, and fully restored after your use.
- 9. **Personal Conduct** Please respect the rights of others to enjoy the park: NO disorderly conduct, loudspeakers, fireworks, public drunkenness, or alcohol.
- 10. No Solicitations at park or ballfield will be permitted.
